#### **Road Safety Act 1986**

#### DECLARATION UNDER SECTION 99B(4) IN RELATION TO THE BEECHWORTH GOLDEN HORSESHOES FESTIVAL GRAND PARADE, BEECHWORTH, ON 4 APRIL 2015

#### 1 Purpose

The purpose of this Declaration is to exempt participants in the Beechworth Golden Horseshoes Festival Grand Parade from specified provisions of the Road Safety Road Rules 2009 with respect to the Event, which is a non-road activity to be conducted on Beechworth–Wangaratta Road (Ford Street) and Beechworth–Wodonga Road (Sydney Road), Beechworth, on 4 April 2015.

#### 2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

#### 3 Commencement

This notice takes effect on 4 April 2015 at 2.00 pm.

#### 4 Expiry

This notice expires on 4 April 2015 at 3.00 pm.

#### 5 Definitions

In this notice, unless the context or subject-matter otherwise requires -

'Event' means the Beechworth Golden Horseshoes Festival Grand Parade, to be held on 4 April 2015; and

'Participants' means participants in the Event, including officers, members and authorised agents of the Golden Horseshoes Committee Inc., whose presence is reasonably required to ensure the safe conduct of the Event.

#### 6 Declaration

I, Michael McCarthy, Acting Executive Director Regional Operations, as delegate of the Minister for Roads, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the Road Safety Road Rules 2009 specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2, on the date and during the period specified in column 2 of Table 2.
