Major Transport Projects Facilitation Act 2009

EAST WEST LINK PROJECT (EASTERN SECTION)

Notice of Appointment of Project Authority

On 19 December 2012, the Governor in Council declared that the East West Link Project (Eastern Section) was a declared project to which the **Major Transport Projects Facilitation Act 2009** applied. (The declaration was gazetted on 20 December 2012).

On 26 February 2013, the Minister for Roads, as Project Minister for the East West Link Project (Eastern Section), gave notice that the Minister had appointed the Linking Melbourne Authority to be the Project Proponent for the project. (The notice was gazetted on 22 March 2013).

The Linking Melbourne Authority is the Project Authority for the East West Link Project (Eastern Section) by reason of being the Project Proponent. (Project Authority is defined in section 3 of the **Major Transport Projects Facilitation Act 2009** as the Project Proponent or, if an entity is appointed by the Minister under section 6 of that Act, that entity).

The effect of this appointment of the Secretary to the Department of Economic Development, Jobs, Transport and Resources under section 6 of the **Major Transport Projects Facilitation Act 2009** is that the Secretary replaces the Linking Melbourne Authority as Project Authority for the East West Link Project (Eastern Section).

Appointment of the Secretary to the Department of Economic Development, Jobs, Transport and Resources as Project Authority for the East West Link Project (Eastern Section)

I, Luke Donnellan, Minister for Roads and Road Safety, as Project Minister for the East West Link Project (Eastern Section), being a project to which the **Major Transport Projects Facilitation Act 2009** applies, give notice pursuant to section 6 of that Act that I have appointed the Secretary to the Department of Economic Development, Jobs, Transport and Resources, being a transport body within the meaning of section 3 of the **Transport Integration Act 2010**, to be the Project Authority for the East West Link Project (Eastern Section).

This appointment takes effect from the date on which this notice is published in the Government Gazette.
