Major Transport Projects Facilitation Act 2009

PENINSULA LINK PROJECT

Notice of Appointment of Project Authority

On 27 January 2010, the Governor in Council declared that the Peninsula Link Project was a declared project to which the **Major Transport Projects Facilitation Act 2009** (other than Parts 3 and 8) applied.

On 2 February 2010, the Minister for Roads and Ports, as Project Minister for the Peninsula Link Project to which the **Major Transport Projects Facilitation Act 2009** applied, gave notice that the Minister had appointed the Southern and Eastern Integrated Transport Authority (SEITA) (trading as Linking Melbourne Authority) to be the Project Proponent for the Peninsula Link Project.

The Linking Melbourne Authority was established under section 134(1) of the **Transport Integration Act 2010** on 1 July 2010. Pursuant to sections 134(2) and 202 of the **Transport Integration Act 2010** and the provisions of the **Interpretation of Legislation Act 1984**, on 1 July 2010 responsibility for the Peninsula Link Project vested in the Linking Melbourne Authority as successor in law to SEITA.

The Linking Melbourne Authority is the Project Authority for the Peninsula Link Project by reason of being the Project Proponent. (Project Authority is defined in section 3 of the **Major Transport Projects Facilitation Act 2009** as the Project Proponent or, if an entity is appointed by the Minister under section 6 of that Act, that entity).

The effect of this appointment of the Roads Corporation as Project Authority for the Peninsula Link Project under section 6 of the **Major Transport Projects Facilitation Act 2009** is that the Roads Corporation replaces the Linking Melbourne Authority as Project Authority for the Peninsula Link Project.

Appointment of the Roads Corporation as Project Authority for the Peninsula Link Project

I, Luke Donnellan, Minister for Roads and Road Safety, as Project Minister for the Peninsula Link Project, being a project to which the **Major Transport Projects Facilitation Act 2009** (other than Parts 3 and 8) applies, give notice pursuant to section 6 of that Act that I have appointed the Roads Corporation (trading as VicRoads), being a body corporate established under section 15 of the **Transport Act 1983** and continued under section 80 of the **Transport Integration Act 2010**, to be the Project Authority for the Peninsula Link Project.

This appointment takes effect from the date on which this notice is published in the Government Gazette.
