VESTING OF CROWN LAND MANAGEMENT IN COURT SERVICES VICTORIA

Order in Council

The Governor in Council, under section 58(1) of the Court Services Victoria Act 2014, divests the management of the Crown land specified in the Schedule to this Order from the person or body that is the current manager of that land and vests the management of that land in Court Services Victoria.

For the avoidance of doubt, this Order does not affect the continuity of any lease, licence or tenancy agreement affecting the land specified in the Schedule.

This Order is effective from 30 June 2015.
