Marine Safety Act 2010

ORDER APPOINTING PERSONS OR BODIES TO BE WATERWAY MANAGERS IN RESPECT OF SPECIFIED STATE WATERS

I, Luke Donnellan, Minister for Ports make the following Orders.

Pursuant to section 6(1) of the **Marine Safety Act 2010** I hereby revoke the appointment of the persons or bodies listed in TABLE 1 of PART 4 – OTHERS, Column 1 in respect of the State waters specified opposite the name of the waterway manager in Column 2 of Table 1.

Pursuant to section 6(1)(b) of the **Marine Safety Act 2010** the order made under section 3(3)(b) of the **Marine Act 1988** and published in the Government Gazette (S220) on 28 June 2012 is amended to declare the persons or bodies listed in TABLE 1 of PART 1 – MUNICIPAL COUNCILS, Column 1 to be a waterway manager in respect of the State waters specified opposite the name of the waterway manager in Column 2 of Table 1.
