#### **Domestic Animals Act 1994**

AMENDMENT OF CODE

## CODE OF PRACTICE FOR THE OPERATION OF BREEDING AND REARING BUSINESSES 2014

I , Jaala Pulford, Minister for Agriculture and Minister responsible for administration of the **Domestic Animals Act 1994** (the Act), in accordance with section 59 of the Act, make the following amendments to the Code of Practice for the Operation of Breeding and Rearing Businesses 2014 (the Code):

#### **Amendments**

- 1. For 'DEPI' (wherever occurring) **substitute** 'DEDJTR'.
- 2. For 'www.depi.vic.gov.au/pets' (wherever occurring) **substitute** 'www.vic.gov.au/pets'.
- 3. In **Section 1 Introduction**, after:

'the enterprise has 10 or more fertile female dogs or 10 or more fertile female cats; or'

#### insert

'the enterprise has between 3 and 9 fertile female dogs or between 3 and 9 fertile female cats in circumstances where more than 2 of the fertile female dogs or fertile female cats (as the case may be) are not registered with the applicable organisation; or'

#### 4. In **Section 1 Introduction**, for:

'Dog breeders with 3–5 fertile breeding dogs (males and females), who are NOT members of an applicable organisation, must comply with Sections 1, 2, 3, 4, 5 and Section 6 Parts 6(1)–6(5)(d).'

#### substitute

'Dog breeders with 3–5 fertile breeding dogs (males and females), who do NOT meet the applicable organisation member exemption, must comply with Sections 1, 2, 3, 4, 5 and Section 6 Parts 6(1)–6(5)(d).'

#### 5. In **Part 1(1) Definitions**, for:

'DEPI: Department of Environment and Primary Industries'

#### substitute

'DEDJTR: Department of Economic Development, Jobs, Transport and Resources'.

# 6. In Part 1(1) Definitions, for the definition of Domestic animal business substitute

'Domestic animal business: has the same meaning as in the Domestic Animals Act 1994.' In Part 1(1) Definitions, in the definition of Hunting dogs for 'Secretary of the DEDJTR' substitute

'Game Management Authority'.

# 7. In **Part 6(3)(c) Breeding females**, after:

'Veterinary practitioners must provide a certificate to state that, at the time of examination, the female is suitable to breed'.

#### insert

'A veterinary practitioner must provide a general health check within 4 weeks prior to all subsequent seasons in which the owner intends to mate the female'.

# 8. In Part 6(4)(a) Exercise and enrichment, for:

'Puppies less than 8 weeks of age must be moved outside of their housing area for exercise each day (see Table 1).'

## substitute

'Puppies more than 8 weeks of age must be moved outside of their housing area for exercise each day (see Table 1).'

## Commencement

These amendments to the Code come into operation on 1 July 2015.
