## Marine Safety Act 2010 Section 259

### ADMINISTRATIVE AMENDMENTS TO WATERWAY RULES

I, Adrian Mnew (as delegate of the Director, Transport Safety), make the following administrative amendments to the notice made under section 15(2) of the **Marine Act 1988** and published in the Victoria Government Gazette No. S 221, Thursday 28 June 2012. These amendments are made under the general power of the Director, Transport Safety in section 259 of the **Marine Safety Act 2010** as necessary or convenient to document the change in the appointed waterway manager for the waters of Hazelwood Cooling Pond pursuant to section 6(1) of the **Marine Safety Act 2010**.

1. After Clause 25 of the Notice in the 'Index to Schedules', (as published in the Victoria Government Gazette No. S 221 on 28 June 2012), after 'Hattah-Kulkyne National Park' and before 'Heywood Lake' under the heading 'Waters', 'Hazelwood Cooling Pondage' delete the words 'Hazelwood Power Corporation Ltd' and insert the words 'Latrobe City Council' under the heading 'Waterway Manager'.
2. In Schedule 110, 'Waters: Hazelwood Cooling Pond', of the Notice (published in the Victoria Government Gazette No. S 221 on 28 June 2012), after the words 'Waterway Manager' delete the words 'Hazelwood Power Corporation Ltd' and insert the words 'Latrobe City Council'.

This notice has effect from the time of publication.
