- 27/2015 (1) This Act comes into operation on the day after the day on which it receives the Royal Assent.
- 28/2015 (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
(2) If a provision of this Act does not come into operation before 1 May 2016, it comes into operation on that day.
- 29/2015 (1) This Part and Part 7 come into operation on the day after the day on which this Act receives the Royal Assent.
(2) Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
(3) If a provision of this Act does not come into operation before 1 January 2016, it comes into operation on that day.
- 30/2015 (1) Subject to subsection (2), this Act comes into operation on a day to be proclaimed.
(2) If this Act does not come into operation before 14 April 2016, it comes into operation on that day.
- 31/2015 (1) This Act comes into operation on the day on which it receives the Royal Assent.
