

Road Discontinuance

Pursuant to section 206 and Schedule 10, Clause 3 of the **Local Government Act 1989**, the Darebin City Council, at its ordinary meeting held on 17 August 2015, formed the opinion that the road at the rear of 37 to 55 Northernhay Street and 38 to 54 Southernhay Street, Reservoir, shown by hatching on the plan below, is not reasonably required as a road for public use and resolved to discontinue the road and to sell the land from the road by private treaty to the adjoining property owners and to transfer to itself any land remaining not sold to the adjoining property owners.

The road is to be sold subject to the right, power or interest held by the Darebin City Council and Yarra Valley Water Corporation in the road in connection with any sewers, drains or pipes under the control of those authorities in or near the road.

WANGARATTA PROPOSAL TO MAKE A MAJOR COUNCIL POLICY CONSULTATION LOCAL LAW

Opportunity to Make a Submission

Wangaratta Rural City Council intends to make a new Local Law, the Major Council Policy Consultation Local Law No. 4 of 2015 (proposed Local Law).

The proposed Local Law prescribes a consultation process that must be followed when Council proposes to determine, make, amend, modify or revoke a Major Council Policy. This is intended to create an enshrined commitment to public consultation on Major Council Policy proposals and provide opportunities for affected people to be heard by Council and for their submissions to be taken into account in Council's deliberations.

The purpose of the proposed Local Law is to:

- prescribe the procedure to be followed before determining, making, amending, modifying or revoking a Major Council Policy;
- ensure transparency and accountability in Council decision-making;
- enhance governance of the municipal district and the local community;
- promote taking into account the diverse needs of the local community in decision-making; and
- provide for the peace, order and good government of the municipal district.

A Local Law Community Impact Statement has been prepared to inform the community about the proposed Local Law and to assist any member of the public who may wish to make a submission to Council.

COMMUNITY LOCAL LAW 2014

At its Ordinary Meeting convened on 8 December 2014, Council resolved to adopt Community Local Law 2014.

The purposes and general purport of the Local Law are to -

- (a) provide for the peace, order and good government of the municipal district;
- (b) regulate activities related to, and ensure the protection of, Council assets;
- (c) protect the health and safety of persons who reside or work in, or visit, the municipal district;

- (d) regulate the management of animals on land and in municipal places;
- (e) protect, maintain and enhance the natural environment of the municipal district; and
- (f) provide uniform and fair administration of the Local Law.

The Local Law and its incorporated documents, together with Council's Local Law Community Impact Statement, can be viewed on Council's website at www.whitehorse.vic. gov.au

Pursuant to section 224A of the Local Government Act 1989, the Council authorises any Police Officer of the Victoria Police to enforce Council's Community Local Law 2014 clause 4.19 – Consumption and possession of liquor.



Primary criterion 7.1 provides that an item may be repealed if it is no longer eligible for listing under any relevant primary criteria from 1 to 6.

Item number 860 has satisfied primary criterion 7.1 as it no longer satisfies the original criteria for listing (1.2 and 1.2.1). National Herbarium of Victoria records for Rare Bitter-bush indicate the widely spread nature of the taxon's Victorian distribution and show that it is well represented in conservation reserves (e.g. Wilsons Promontory NP). The current distribution, expanded as a consequence of taxonomic revision, has the taxon occurring in at least 15 ten-minute grids.

Item number 861 has satisfied primary criterion 7.1 as it no longer satisfies the original criteria for listing (1.1, 1.2 and 1.2.1). Western Water-starwort is no longer recognised as a distinct species by the National Herbarium of Victoria and is now considered to be a synonym of Winged Water-starwort (*C. umbonata*).


