

Pursuant to section 206 and Schedule 10, Clause 3 of the **Local Government Act 1989**, the Colac Otway Shire Council at its Ordinary Meeting held on 28 October 2015 formed the opinion that a section of the unused road described as the Government Road within Lot 2, on plan of subdivision LP128917, Parish of Wongarra, shown hatched on the plan below, is not reasonably required as a road for public use. Council resolved to discontinue that portion of the road for the purpose of enabling the Crown to transfer the land to the abutting land owner.

BAW BAW PLANNING SCHEME

Notice of the Preparation of an Amendment

Amendment C89

The Baw Baw Shire Council has prepared Amendment C89 to the Baw Baw Planning Scheme. There are multiple land parcels affected by the Amendment across the municipality. The Amendment proposes to:

1. delete redundant Development Plan Overlays:

- delete Schedule 1, 2, 5 and 6 to Clause 43.04 Development Plan Overlay (DPO) as they do not correspond to any mapping areas in the Baw Baw Planning Scheme;
- delete mapping of DPO Schedule 3 where land has been developed (or is a redundant provision) in Drouin and Warragul;

2. implement the Drouin Structure Plan:

- by rezoning land at 13–15 McGlone Road, Drouin (Drouin Golf Club), from Farm Zone to Low Density Residential Zone, applying the DPO7 and the deletion of the DPO3;
- by rezoning land at 40 Pryor Road, Drouin, from Farm Zone to General Residential Zone Schedule 1, introducing DPO7 and updating the Drouin Structure Plan;
- 3. rezone land from Industrial Use Zone 1 to Public Park and Recreation Zone at 19–21 Burke Street, Warragul, to facilitate the development and ongoing use of the land as the Warragul Leisure Centre;
- introduce a new schedule (Public Acquisition Overlay Schedule 3 Roadworks) and apply PAO3 to part of 41 Sutton Street, Warragul (Warragul Golf Club) to facilitate intersection roadworks;
- 5. apply the Public Use Zone 1 to land within Gippsland Water's ownership to facilitate ownership and management of water/sewerage infrastructure;
- apply the Public Parks and Recreation Zone to reserves that have been transferred into Council's ownership to facilitate ongoing management of public open space;
- 7. undertake Heritage Overlay adjustments:
 - delete Heritage Overlay Mapping over 291 Darnum–Allambee Road, Darnum;
 - delete Heritage Overlay HO148 and associated mapping over 60 Victoria Street, Warragul;
 - delete Heritage Overlay Mapping over 101 Victoria Street, Warragul;
 - delete Heritage Overlay Mapping over 2396 Willow Grove Road, Hill End, in relation to HO274;
 - introduce Heritage Overlay Mapping to the buildings identified in HO274 (St James Anglican Church) and amend Clause 43.01 to show the correct address and citing for HO274 (Willow Grove Road, Hill End – Lot 1 LP83794);
- 8. apply the underlying zones of roads that are no longer under the administration of VicRoads; and
- 9. undertake mapping anomaly corrections.

Notice of Preparation of Amendment

Amendment C42

The Northern Grampians Shire Council has prepared Amendment C42 to the Northern Grampians Planning Scheme.

The Amendment affects land in the Halls Gap Township susceptible to landslides. The Amendment map shows the specific land affected by the Amendment.

The Amendment proposes to apply the Erosion Management Overlay (EMO) and Schedule 2 to the Northern Grampians Planning Scheme. Schedule 2 to the EMO is to be used to manage landslide hazards. The Amendment will also amend Clause 21.10 (Environment) and Local Planning Policy Clause 22.04 (Halls Gap/Lake Bellfield) to recognise landslide hazards. The Amendment would implement recommendations made in the GHD and A. S. Miner 'Northern Grampians Shire Council, Report for Landslide Susceptibility Zoning, Halls Gap Township, September 2011'.

The Amendment implements the Northern Grampians Shire Council, Report for Landslide Susceptibility Zoning, Halls Gap Township, September 2011'. The Amendment proposes to:

- apply the Erosion Management Overlay (EMO2) to land susceptible to landslides in the township of Halls Gap to implement key recommendations of the GHD and A. S. Miner 'Northern Grampians Shire Council, Report for Landslide Susceptibility Zoning, Halls Gap Township, September 2011';
- insert a new Schedule 2 to Clause 44.01 Erosion Management Overlay for land susceptible to landslides in the township of Halls Gap to manage the risk of landslides;
- amend Clause 21.10 (Environment) to include the risk of landslides in the overview, list of key strategic issues and to include an objective and associated strategies;
- amend Clause 22.04 (Halls Gap/Lake Bellfield Policy) to include an objective which recognises land susceptible to landslides in Halls Gap;
- amend the Schedule to Clause 44.01 Erosion Management Overlay to include a Schedule number;
- amend the Schedule to Clause 61.03 to include new Planning Scheme Maps in the Northern Grampians Planning Scheme;
- insert new Planning Scheme EMO Maps 35, 36 and 37; and
- delete Planning Scheme EMO Map 9 and insert a new Planning Scheme Map 9EMO to address the numbering of the EMO Schedules to Clause 44.01.





The Amendment implements the 'North Warrnambool Flood Study (2010)', 'South Warrnambool Flood Study (2007)' and 'Dennington Flood Study (2007)' as they relate to land in the Russell Creek floodplain (downstream of Bromfield Street), Merri River floodplain in South Warrnambool (upstream of Block Street) and Merri River floodplain in North Warrnambool (except for areas adjoining Membery Way, 123 Queens Road, and 2–18 Daltons Road), by:

- applying the Urban Floodway Zone or Floodway Overlay to areas identified as high hazard flood risk during a 1 in 100 year storm event;
- applying the Land Subject to Inundation Overlay to areas identified as subject to inundation during a 1 in 100 year storm event;
- amending Clause 22.02-1 to remove references to the 'Urban Areas Land Liable to Flooding Background Report, June 1994' and include references to the 'North Warrnambool Flood Study (2010)', 'South Warrnambool Flood Study (2007)' and 'Dennington Flood Study (2007)'. Note: further review of Clause 22.02 will occur as part of Council's review of the Municipal Strategic Statement and Local Planning Policy; and
- amending the Schedule to Clause 61.03 to update map descriptions to reflect the new maps.
