ORDER REVOKING AND APPOINTING PERSONS OR BODIES TO BE WATERWAY MANAGERS IN RESPECT OF SPECIFIED STATE WATERS

I, Luke Donnellan, Minister for Ports make the following Orders.

Pursuant to section 6 of the **Marine Safety Act 2010**, I hereby revoke the appointment of the persons or bodies listed in Column 1 of Table 1, Part 1 to be a waterway manager in respect of the State waters specified opposite the name of the waterway manager in Column 2 of Table 1, Part 1 as published in the Victoria Government Gazette, No. S 220 Thursday 28 June 2012.

ADMINISTRATIVE AMENDMENTS TO WATERWAY RULES

- I, Peter William Corcoran, Director Maritime Safety (as delegate of the Director, Transport Safety) make the following administrative amendments to the notice published in the Victoria Government Gazette No. S 1, Monday 4 January 2016. These amendments are made under the general power of the Director, Transport Safety in section 259 of the **Marine Safety Act 2010** as necessary or convenient to document the change in the management status for the waters of Taylors Creek pursuant to section 6(1) of the **Marine Safety Act 2010**.
- After Clause 25 in the 'Index to Schedules', as published in the Victoria Government Gazette
 No. S 221 on 28 June 2012 and amended in the Victoria Government Gazette No. S 1,
 Monday 4 January 2016:
 - (a) after 'Tamboon Inlet and all the navigable waters with an opening to that inlet' and
 - (b) before 'Taylors Lake (Horsham)'
 - under the heading 'Waters', 'Taylors Creek' delete the words 'Shire Of Campaspe' and insert the word 'Unmanaged' under the heading 'Waterway Manager'.

2. In Schedule 19, 'Waters: Taylors Creek', of the Notice (No. S 1, Monday 4 January 2016), after the words 'Waterway Manager' delete the words 'Shire Of Campaspe' and insert the word 'Unmanaged'.
