#### Order in Council

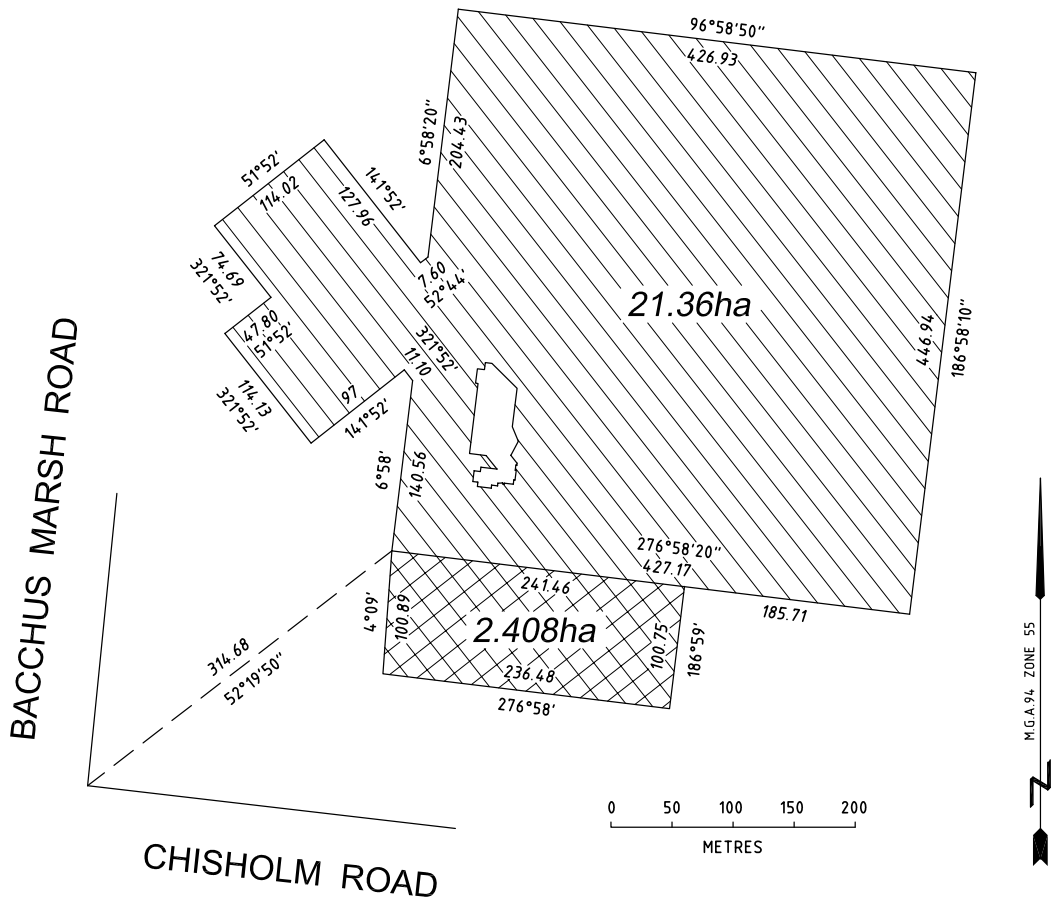

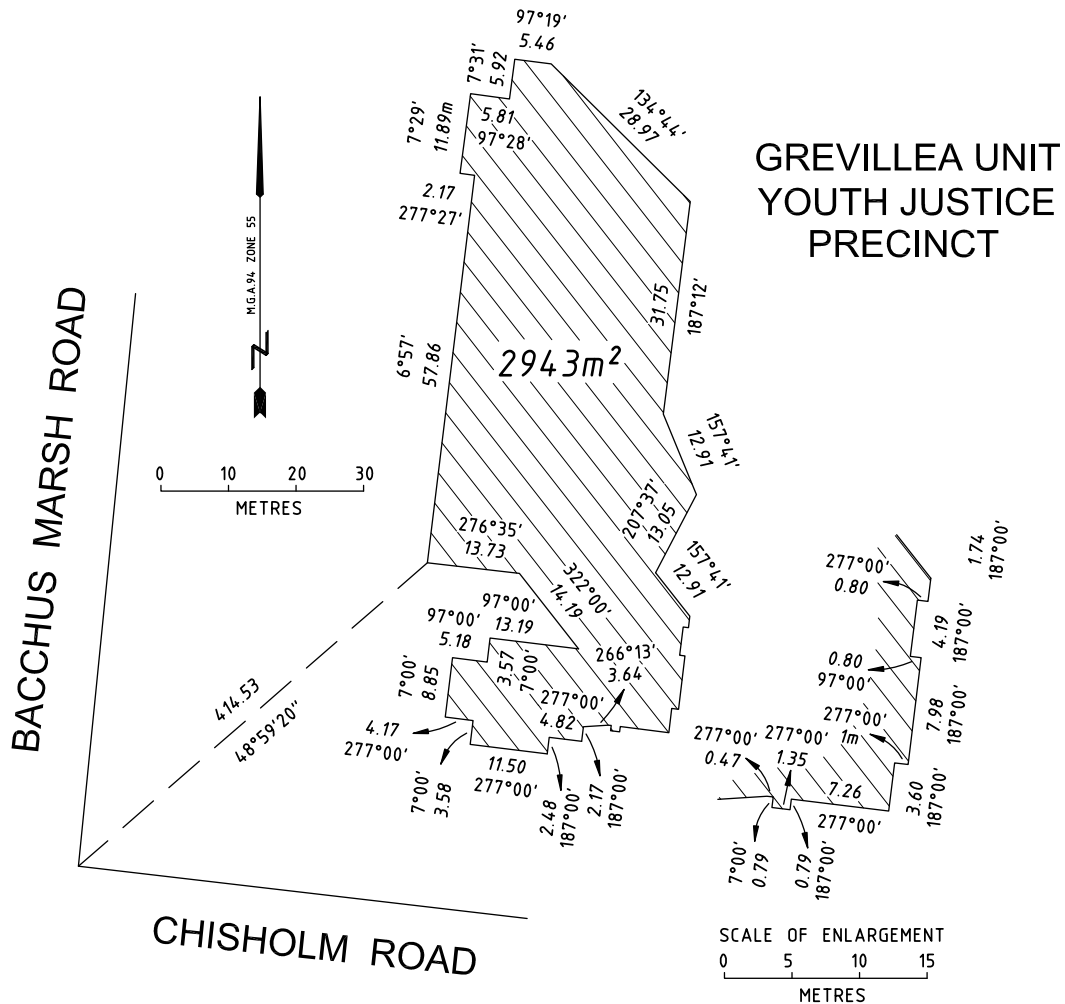

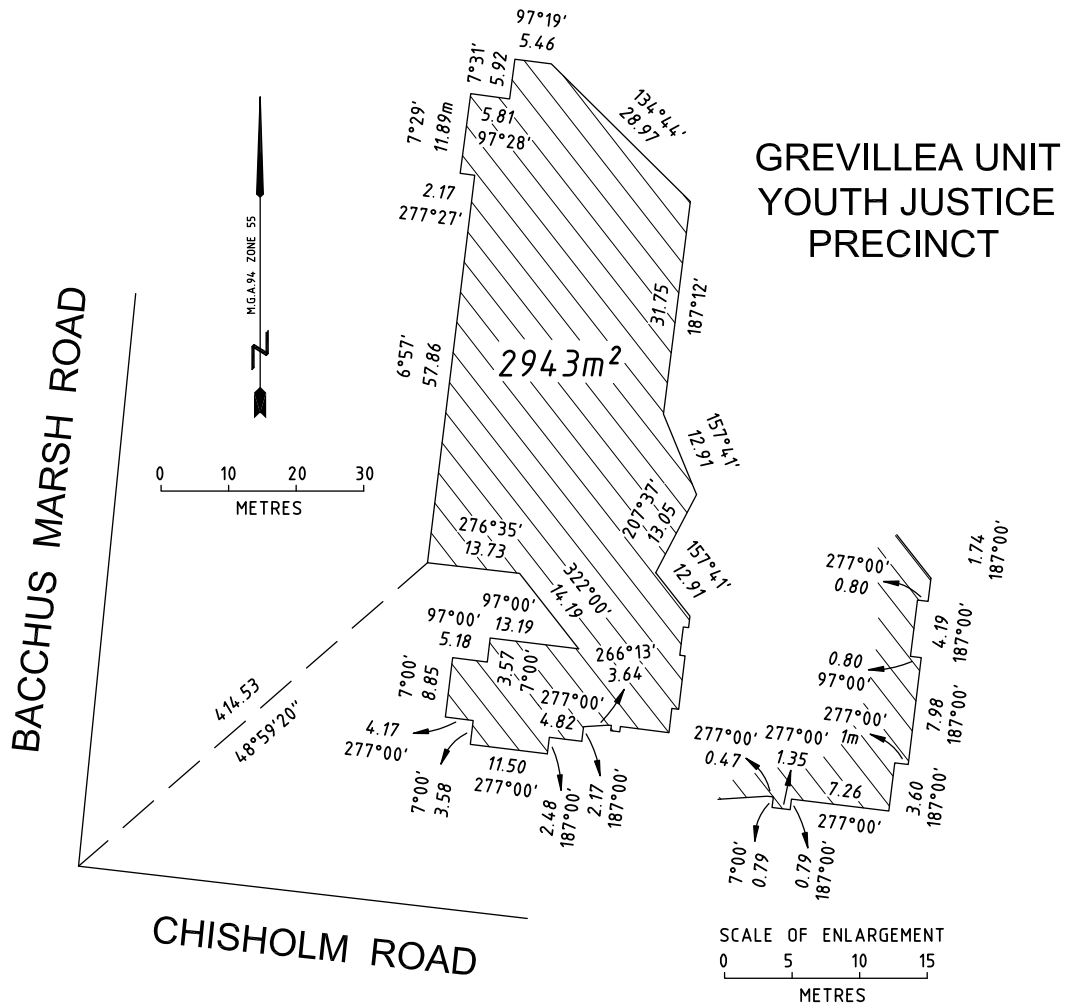
