73/2016	(1)	This Part, sections 3, 6, 7, 9, 10, 12, 16, 17 and 18 and Part 6 come into operation on the day after the day on which this Act receives the Royal Assent.	
	(2)	Part 3 and section 22 are taken to have come into operation on 1 July 2014.	
	(3)	Sections 4, 8, 11(2), 13, 14 and 20 come into operation on 1 July 2017.	
	(4)	Subject to subsection (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.	
	(5)	If a provision referred to in subsection (4) does not come into operation before 11 October 2017, it comes into operation on that day.	
74/2016	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.	
	(2)	If a provision of this Act does not come into operation before 1 March 2017, it comes into operation on that day.	
75/2016	(1)	Subject to subsection (2), this Act comes into operation on a day to be proclaimed.	
	(2)	If this Act does not come into operation before 1 October 2017, it comes into operation on that day.	
76/2016	(1)	This Act (except Division 2 of Part 3) comes into operation on the day after the day on which it receives the Royal Assent.	
	(2)	Subject to subsection (3), Division 2 of Part 3 comes into operation on a day to be proclaimed.	
	(3)	If Division 2 of Part 3 does not come into operation before 6 June 2017, it comes into operation on that day.
