#### **Education and Training Reform Act 2006**

ORDER AMENDING MINISTERIAL ORDER NO. 615 – AMENDMENT TO ORDER FIXING OF FEES ADMINISTERED BY THE VICTORIAN REGISTRATION AND QUALIFICATIONS AUTHORITY

Ministerial Order No. 957

The Minister for Education and the Minister for Training and Skills make the following Order.

#### TITLE

1. This Order may be cited as Ministerial Order No. 957.

#### PURPOSE

2. This Order amends Ministerial Order No. 615 which fixes fees in respect of applications that may be made to the Victorian Registration and Qualifications Authority and for certificates.

#### AUTHORISING PROVISIONS

3. This Order is made under sections 4.3.16(3)(bc), 4.3.19(2)(a), 4.4.1(6), 4.4.2(1)(d), 5.2.13, 5.10.4 of, and item 3 of Schedule 6 to, the Education and Training Reform Act 2006.

#### COMMENCEMENT

4. This Order takes effect from the date that it is published in the Government Gazette.
