

The road, once discontinued, will be sold to the owner of 38 Roxby Street, Manifold Heights 3218.






 Behind the McMillan Street Precinct in Anglesea, at the rear of 1, 1A and 1B McMillan Street, Anglesea.

Notice is hereby given that the Cardinia Shire Council at its meeting held on 21 March 2016 resolved to make Local Law 18, Open Air Fires Amendment Local Law.

The purposes and general purport of the Local Law are to:

- provide for the peace, order and good government of the Cardinia Shire Council; and
- promote a physical and social environment free from hazards to health, in which the residents of the municipal district can enjoy a quality of life that meets the general expectations of the community; and
- prevent and suppress nuisances which may adversely affect the enjoyment of life or the health, safety and welfare of persons; and
- prohibit, regulate and control activities which may be dangerous or unsafe or detrimental to the quality of life and the environment;
 and
- prohibit and regulate the use of open air fires to reduce green waste and bush fire and wild fire risk in the municipal district; and
- provide for the consistent application and enforcement of this Local Law.

Education and Training Reform Act 2006

NOTIFICATION CANCELLING REGISTRATION OF A TEACHER

Pursuant to section 2.6.29 of the **Education and Training Reform Act 2006**, the Victorian Institute of Teaching must disqualify a registered teacher from teaching and cancel his/her registration where that person has been convicted or found guilty at any time in Victoria or elsewhere of a sexual offence.

On 2 March 2016, Melissa Bonaddio was convicted of the following sexual offences:

a) 2 counts of an indecent act with a 16 or 17 year old child under her care, supervision or authority.

On 2 March 2016, Melissa Bonaddio was disqualified from teaching and her registration as a teacher in Victoria was cancelled.

REVOCATION OF DETERMINATION OF FIREWOOD COLLECTION AREA
