ADMINISTRATIVE ARRANGEMENTS ORDER (NO. 221) 2016

The Governor in Council makes the following Order:

1. Title

This Order is called the Administrative Arrangements Order (No. 221) 2016.

2. Authorising provision

This Order is made under section 3 of the **Administrative Arrangements Act 1983**.

3. Commencement

This Order takes effect on 1 March 2016.

4. Definitions

In this Order -

'Body' means Minister, Department or officer;

'instrument' includes contract and agreement;

'New Body' means a Body specified in Column 3 of an item in the Table of the Schedule;

'Old Body' means a Body specified in Column 1 of an item in the Table of the Schedule;

'Schedule' means the Schedule to this Order;

'transaction' includes -

- (a) agreement, bond, contract, deed or other consensual arrangement; and
- (b) action, appeal, arbitration, prosecution or other legal proceeding; and
- (c) assignment, charge, lease, mortgage, transfer or other dealing with property; and
- (d) loan, guarantee, indemnity or other dealing with money; and
- (e) approval, consent, delegation, direction, licence, order, permit, requirement or other authority; and
- (f) notice; and
- (g) any other act, entitlement or liability at law.

5. Construction of references

In respect of each item in the Table of the Schedule, a reference to an Old Body –

- (a) in a provision of an Act specified in Column 2 of an item in the Table of the Schedule; or
- (b) in a statutory instrument or other instrument made under an Act specified in Column 2 of an item in the Table of the Schedule; or
- (c) in respect of any other matter or thing done under a provision of an Act specified in Column 2 of an item in the Table of the Schedule; or
- (d) in an instrument specified in Column 2 of an item in the Table of the Schedule is taken to be a reference to the New Body.

6. Saving of existing transactions

If a transaction happened in relation to an Old Body before this Order takes effect –

- the transaction shall continue in the same way as it would have continued if this Order (a) had not been made: and
- (b) the transaction may be given effect to, or enforced or completed, by or in relation to the New Body in the same way as it would have been given effect to, or enforced or completed, by or in relation to the Old Body if this Order had not been made.

7. Keeping financial accounts and reports

- The Secretary, Department of Premier and Cabinet must ensure that financial accounts are kept and reports are provided for the purposes of the Financial Management Act 1994 for the period commencing 1 July 2015 and ending on 29 February 2016 in respect of a function under an Act specified in item 5, 6, 8 or 9 in the Table of the Schedule that is transferred to the Secretary, Department of Treasury and Finance as if the function had not been transferred.
- (2) The Secretary, Department of Economic Development, Jobs, Transport and Resources must ensure that financial accounts are kept and reports are provided for the purposes of the Financial Management Act 1994 for the period commencing 1 July 2015 and ending on 29 February 2016 in respect of a function under an Act specified in item 14 or 15 in the Table of the Schedule that is transferred to the Secretary, Department of Health and Human Services as if the function had not been transferred
- (3) The Secretary, Department of Treasury and Finance must ensure that financial accounts are kept and reports are provided for the purposes of the Financial Management Act 1994 for the period commencing 1 July 2015 and ending on 29 February 2016 in respect of a function under an Act specified in item 17 or 18 in the Table of the Schedule that is transferred to the Secretary, Department of Health and Human Services as if the function had not been transferred.
- The Secretary, Department of Environment, Land, Water and Planning must ensure (4) that financial accounts are kept and reports are provided for the purposes of the Financial Management Act 1994 for the period commencing 1 July 2015 and ending on 29 February 2016 in respect of a function under an Act specified in item 24 or 25 in the Table of the Schedule that is transferred to the Secretary, Department of Economic Development, Jobs, Transport and Resources as if the function had not been transferred.

8. Providing financial accounts and reports

A Secretary to a Department to which a function is transferred must, if requested by a Secretary to a Department who is an Old Body, provide that Old Body with any financial accounts and records or other information required to enable the Old Body to comply with clause 7.
