#### Crown Land (Reserves) Act 1978

CROWN LAND RESERVES (OCEAN GROVE PUBLIC PURPOSES RESERVE)
(EXTENSION OF APPLICATION) REGULATIONS 2016

I, Lisa Neville MP, Minister for Environment, Climate Change and Water, make the following Regulations.

#### 1. Objectives

The objectives of these Regulations is to extend the Crown Land Reserves (Ocean Grove Public Purposes Reserve) Regulations 2009 to apply to the Crown land reserves listed in the Schedule to ensure the care, protection and management of those reserves.

#### 2. Authorising provision

These Regulations are made under section 13 of the Crown Land (Reserves) Act 1978.

#### 3. Commencement

These Regulations come into operation on the date they are published in the Victoria Government Gazette.

4. Extension of application of the Crown Land Reserves (Ocean Grove Public Purposes Reserve) Regulations 2009.

The Crown Land Reserves (Ocean Grove Public Purposes Reserve) Regulations 2009 are extended to apply to the Crown land reserves listed in the Schedule, being reserved lands managed by the committee of management of the Ocean Grove Public Purposes Reserve.

5. Construction of reference to the reserve in the Crown Land Reserves (Ocean Grove Public Purposes Reserve) Regulations 2009.

The Crown Land Reserves (Ocean Grove Public Purposes Reserve) Regulations 2009, which have been extended by Regulation 4, apply to a reserve listed in the Schedule, as if a reference in those Regulations to the reserve were a reference to that reserve.

#### **SCHEDULE**

### RESERVES TO WHICH THESE REGULATIONS APPLY

- 1. The reserved Crown lands in the Parish of Bellarine known as Ocean Grove Foreshore Reserve and as indicated by blue colour on plan LEGL./14-032 lodged in the Central Plan Office Victoria. (0701875).
- 2. The reserved Crown lands in the Parish of Conewarre and Township of Barwon Heads known as Barwon Heads and 13th Beach Foreshore Reserve and Barwon Heads Park and as indicated by blue colour on plan LEGL./14-031 lodged in the Central Plan Office Victoria. (0701587 and 0704538).
