Notice of Approval of Amendment
Amendment GC37

The Minister for Planning has approved Amendment GC37 to the Cardinia, Casey, Glen Eira, Greater Dandenong, Kingston, Melbourne, Monash, Stonnington and Yarra Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment facilitates the Caulfield Dandenong Rail Upgrade Project which includes the removal of nine level crossings on the Cranbourne Pakenham line between Caulfield and Dandenong, the redevelopment of five railway stations at Carnegie, Murrumbeena, Hughesdale, Clayton and Noble Park, and new and upgraded infrastructure between the city loop and Cranbourne and Pakenham railway stations.
