

The Road is to be sold subject to any right, power or interest held by City West Water Corporation in connection with any sewers, drains or pipes under the control of that authority in the Road.



Proposed Asset Protection Local Law 2016 and Amendment of Community Local Law 2/2010

Notice is hereby given that Casey City Council intends to make the proposed Asset Protection Local Law 2016 and amendment of the Community Local Law 2/2010 in accordance with section 119 of the Local Government Act 1989 (the Act).

The purpose and general purport of the proposed Asset Protection Local Law and amendment to Community Local Law 2/2010 is to reduce the impacts of damage to public assets caused by building and construction works in the municipality, and to provide for the safety and health of the public by controlling activities associated with building and construction works in the municipality. These changes are considered to be relevant and consistent with industry practice.

The proposed Asset Protection Local Law 2016 and repeal of Clause 16.4 of Community Local Law 2/2010 are being made under section 111 of the Act and will operate throughout the municipal district of Casey City Council.

A Community Impact Statement has been prepared to inform the community about the proposed Asset Protection Local Law 2016 and repeal of Clause 16.4 of Community Local Law 2/2010 to assist any member of the public who may wish to make a submission to Council.

A copy of the proposed Asset Protection Local Law 2/2010 and Community Impact Statement inclusive of the amendment to Community Local Law 2/2010 is available for viewing on Council's website and for inspection at the City of Casey offices, Magid Drive, Narre Warren.

Any person may make a written submission on the proposal under section 223 of the Act and submissions must be received by Thursday 30 June 2016.

A person who has made a written submission and requested that they be heard in support of their submission, is entitled to appear in person or by a person acting on their behalf before a General Purposes Committee meeting.

Submissions made under section 223 of the Act are not confidential and:

- will be incorporated in full (including person's name and suburb) into the agenda and minutes of any Council or Committee meeting at which the matter is considered;
- will be available on Council's website as part of any relevant Council or Committee agenda and minutes; and
- must be made available for public inspection in accordance with the provisions of the Act.

All submissions will be considered in accordance with section 223 of the Act.

Notice is hereby given that, at its meeting on 26 April 2016, Whittlesea City Council resolved to designate five additional off leash dog parks to the schedule of designated area in its Order Number 1 under section 26 of the **Domestic Animals Act 1994** (the Act).

ORDER NO. 1 OF WHITTLESEA CITY COUNCIL

Section 26 Domestic Animals Act 1994

1. Dogs must be under effective control

- (1) The Owner of any dog must keep the dog under effective control by means of a chain, cord or leash held by the Owner and attached to the dog while the dog is in:
 - a reserve; or
 - a Public Place

except where that reserve or Public Place is a Designated Area.

(2) Sub-clause (1) does not apply where a chain, cord or leash attached to the dog is securely fastened to a post or other fixture and the dog remains under sight or voice control by the Owner.

2. Owner's obligations in a Designated Area

- (1) A dog may be exercised off a chain, cord or leash in a Designated Area, if the Owner:
 - carries a chain, cord or leash sufficient to bring the dog under control by placing the dog on a chain, cord or leash if the dog behaves in a manner which threatens any person or animal;
 - remains in effective voice and/or hand control of the dog and within constant sight of the dog so as to be able to promptly bring the dog under control by placing the dog on a chain, cord or leash if that becomes necessary or desirable to avoid any wandering out of effective control or to avoid any threatening behaviour or any attack;
 - carries a bag, receptacle or other means of picking up, and removing from the Designated Area, any of the dog's faeces; and
 - does not allow the dog to worry or otherwise threaten any person or animal, and does not allow the dog to attack any person or animal.
- (2) Notwithstanding anything else in this Order, an owner of a dog must keep the dog under effective control by means of a chain, cord or leash held by the Owner if the dog is within 20 metres of:
 - an area where an organised sporting event or the practising thereof is taking place;
 - a children's play equipment area;
 - an area where a public meeting is being held; or
 - a permanently designated barbeque or picnic area.
- (3) An owner of a dog must not attempt to exercise more than four (4) dogs in a Designated Area at any one time.

3. Non application to dangerous dogs or greyhounds

Clause 2 of this Order does not apply to any dog which is a dangerous dog under the **Domestic Animals Act 1994**, or to a greyhound which must meet the restraint requirements in section 27 of this Act.

4. Meaning of words

In this Order:

Designated Area means an area described as such in the Schedule, in which a dog may be exercised in the manner set out in clause 2 of this Order.

Owner has the same meaning as in the Domestic Animals Act 1994.

Notice of Decision

I, Martin Pakula MP, Attorney-General, give notice under section 12 of the **Subordinate Legislation Act 1994** of my decision to make the proposed Infringements Regulations 2016.

A regulatory impact statement was prepared in relation to the proposed Regulations. Thirteen submissions were received and have been considered. The key issues raised related to:

- the extent of consultation with municipal councils in the preparation of the regulatory impact statement;
- the impact on municipal council budgets of the proposed penalty reminder notice fee and lodgement fee settings;
- the assumptions, methodology and weighting approach used to calculate the fee settings;
- the fact that the lodgement fee is based on enforcement activity costing rather than fine recovery rates;
- the potential likelihood that, if the lodgement fee is raised, municipal councils will enforce more matters through the Magistrates' Court:
- a request to correct minor errors in the list of lodgeable infringement offences under the **Environment Protection Act 1970** in proposed Schedule 16; and
- the impact of infringement debt on vulnerable groups and other issues which were outside the scope of the proposed regulations and the fees analysis in the regulatory impact statement.

After consideration of the submissions, I have decided that the proposed Regulations should be made, save for minor and technical amendments for the purpose of drafting consistency and clarity and to ensure that all necessary provisions have been included in the schedules of lodgeable infringement offences.
