ROAD CLOSURES GUNBOWER ISLAND 2016

Section 21(1)(ea) Determination

Section 21(1)(ea) of the **Forests Act 1958** provides that the whole or any part of a road or track constructed or maintained by the Secretary may be closed temporarily by the erection of barriers.

Therefore I, Heather Shaw, Acting Assistant Chief Fire Officer, Loddon Mallee, determine under Section 21(1)(ea) of the **Forests Act 1958** that the roads indicated in Schedule 1 hereto appended are roads which are closed for the periods indicated.
