### Crown Land (Reserves) Act 1978


ORDER GIVING APPROVAL TO THE GRANT OF LEASES UNDER SECTIONS 17D(1) AND 17D(3)(A)

Under sections 17D(1) and 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, I, the Hon. Lily D'Ambrosio MP, Minister for Energy, Environment and Climate Change, being satisfied that there are special reasons which make the granting of the leases reasonable and appropriate in the particular circumstances and to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the **Crown Land (Reserves) Act 1978**, approve the granting of leases to various tenants for commercial purposes including Café, Commercial Kitchen and Office Space by the City of Greater Geelong as the Committee of Management over portion of Johnstone Park Reserve being the Crown land described in the Schedule below and, in accordance with section 17D(3)(a) of the **Crown Land (Reserves) Act 1978**, state that:

- (a) there are special reasons which make granting the lease reasonable and appropriate in the particular circumstances; and
- (b) to do this will not be substantially detrimental to the use and enjoyment of any adjacent land reserved under the Crown Land (Reserves) Act 1978.

### SCHEDULE

The land indicated by hatching on the attached plan being portion of Allotment 1, Section 55B, City of Geelong, Parish of Corio, being the Crown land permanently reserved for Public Park purposes by Order in Council of 12 November 1877 (vide Government Gazette of 15 November 1877 page 2168).
