


ROAD DECLARATION - PARKLANDS CLOSE, DONVALE

Manningham City Council, at its meeting of 31 May 2016, acting in pursuance of section 11 of the **Road Management Act 2004** (the RM Act), resolved to declare the land shown stippled on the accompanying plan, and known as Parklands Close, Donvale, to be a road.

ROAD DEVIATION - SPRINGVALE ROAD, DONVALE

Manningham City Council, at its meeting of 26 July 2016, acting in pursuance of section 207B and Clause 2 of Schedule 10 of the Local Government Act 1989 (the LG Act), and having considered submissions in accordance with section 223 of the LG Act, resolved to deviate the road known as Springvale Road, Donvale, and shown hatched on the plan below to the land shown cross-hatched on the plan below. Once the discontinued road has been deviated, the land comprising the former road will be retained by Manningham City Council.

The consent of the Minister for Environment, Climate Change and Water, as Minister administering the Land Act 1958, was obtained on 19 April 2016, as required by Clause 2 of Schedule 10 of the LG Act.






ROAD DISCONTINUANCE

Pursuant to section 206 and Schedule 10, Clause 3 of the **Local Government Act 1989**, the Moonee Valley City Council at its meeting on 23 August 2016, formed the opinion that the section of road abutting 3/14 and 16 Fawkner Street, Aberfeldie, shown hatched on the plan below, is not reasonably required as a road for public use and resolved to discontinue the road and sell the land to the abutting owners.

The section of road shown hatched is to be discontinued subject to the right, power or interest held by City West Water and Moonee Valley City Council in the road in connection with any sewers, drains or pipes under the control of that authority in or near the road.





ORDER PROHIBITING OR RESTRICTING THE ENTRY OR IMPORTATION OF POTATO SPINDLE TUBER VIROID HOST MATERIAL INTO VICTORIA

I, Gabrielle Vivian-Smith, as delegate of the Minister for Agriculture, being of the reasonable suspicion that the exotic disease potato spindle tuber viroid (PSTVd) exists within Australia but outside Victoria, make the following Order.

1 Objective

The objective of this Order is to prohibit, restrict or impose conditions upon the entry or importation into Victoria of PSTVd host plants.

2 Authorising provision

This Order is made under section 36(1) of the Plant Biosecurity Act 2010 (the Act).

3 Commencement

This Order comes into force on the day of making.

4 Revocation

The Order made under section 36 of the **Plant Biosecurity Act 2010**, and published in Government Gazette G35 on 3 September 2015 at page 1905, is revoked.

5 Definitions

In this Order –

'PSTVd host plant' means a seed potato or any other potato intended for planting or propagation, including plants in tissue culture.

6 **Prohibitions, restrictions and conditions**

The following prohibitions, restrictions and conditions are specified in relation to the entry or importation of PSTVd host plants.

- (a) The entry or importation into Victoria of any PSTVd host plant is prohibited.
- (b) Subclause (1) does not apply if the PSTVd host plant
 - (i) was grown on or sourced from a property that is located in a State or Territory, or part of a State or Territory, for which an area freedom certificate issued by an officer responsible for agriculture in the State or Territory where the plant was grown or sourced is currently in force certifying that the State or Territory or part of the State or Territory is known to be free of PSTVd; or
 - (ii) is produced and certified by a business accredited under the seed potato certification scheme operated by the Victorian Certified Seed Potato Authority (ViCSPA); or
 - (iii) is accompanied by a plant health certificate, assurance certificate or plant health declaration, certifying or declaring that the plant has been tested or treated in accordance with the requirements described in Schedule 1.

7 Verification of Consignments

- (1) Where requested by an inspector, a PSTVd host plant entering or being imported into Victoria which is required by clause 6(b)(ii) to be accompanied by a certificate or declaration, must be –
 - (a) presented to an inspector for inspection; or
 - (b) verified by a person accredited to do so by the Department of Economic Development, Jobs, Transport and Resources.

8 Expiry

This Order remains in force for a period of 12 months after the day of making.

Schedule 1

PSTVd host plants must be sourced from a crop which has been sampled and tested, and found free of PSTVd; where –

- (a) sampling means 200 leaves are taken at random from the crop during the growing season; and
- (b) testing means analysis in a diagnostic laboratory.

Notes:

Section 38 of the Act provides that it is an offence for a person to cause, permit or assist any plant, plant product, plant vector, used equipment, used package, earth material or beehive to enter Victoria in contravention of an importation under section 36. The maximum penalty of 60 penalty units applies in the case of a natural person and 300 penalty units in the case of a body corporate.

Terms in this Order that are defined in the Act have that meaning.




