Notice of Approval of Amendment Amendment GC13

The Minister for Planning has approved Amendment GC13 to the Alpine; Alpine Resorts; Ararat; Ballarat; Banyule; Bass Coast; Baw Baw; Benalla; Buloke; Campaspe; Cardinia; Casey; Central Goldfields; Colac Otway; Corangamite; East Gippsland; Frankston; French Island and Sandstone Island; Gannawarra; Glenelg; Golden Plains; Greater Bendigo; Greater Geelong; Greater Shepparton; Hepburn; Hindmarsh; Horsham; Hume; Indigo; Knox; Latrobe; Loddon; Macedon Ranges; Manningham; Mansfield; Maroondah; Melton; Mildura; Mitchell; Moira; Moorabool; Mornington Peninsula; Mount Alexander; Moyne; Murrindindi; Nillumbik; Northern Grampians; Pyrenees; Queenscliffe; South Gippsland; Southern Grampians; Strathbogie; Surf Coast; Swan Hill; Towong; Wangaratta; Warrnambool; Wellington; West Wimmera; Whitehorse; Whittlesea; Wodonga; Yarra Ranges; Yarriambiack Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment updates the mapping and ordinance for the Bushfire Management Overlay across Victoria by:

- Inserting updated BMO maps into 64 planning schemes.
- Inserting schedules to Clause 44.06 in 47 planning schemes
- Deleting redundant references to the Wildfire Management Overlay (WMO)
- Deleting the BMO (maps and ordinance) in some areas where the vegetation no longer meets the criteria as set out in Advisory Note 46.
- Amending schedules to clause 61.03 for planning schemes to update the maps listed in the scheme.
