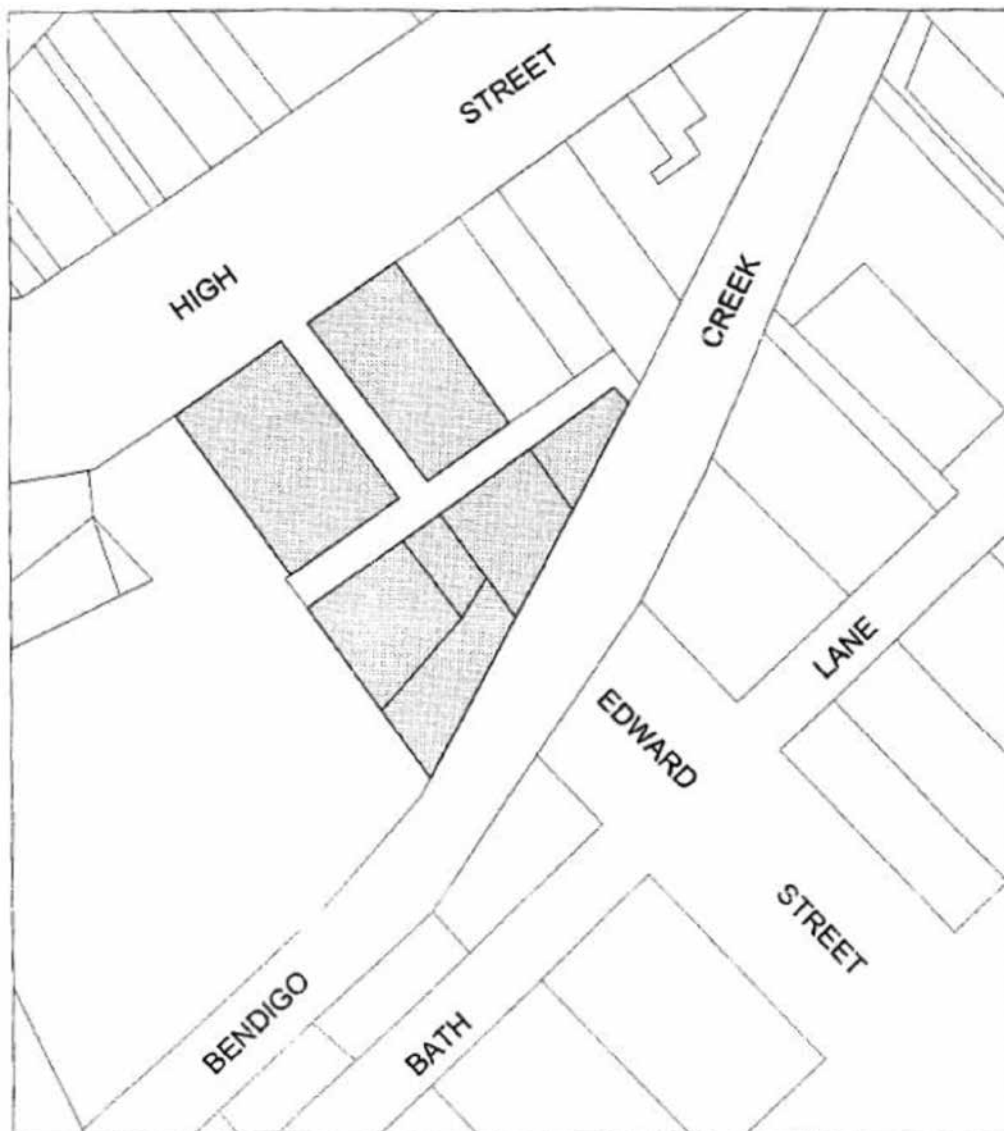

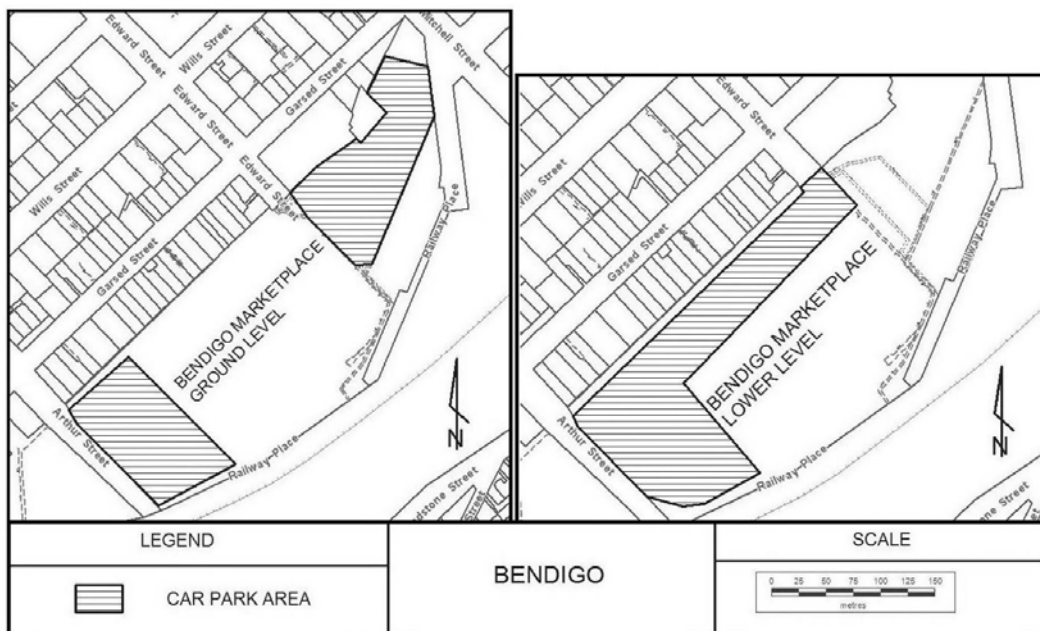
**REVOCATION OF AN ORDER UNDER SECTION 98 OF THE ROAD SAFETY ACT 1986**
