Notice of Approval of Amendment

Amendment GC28

The Minister for Planning has approved Amendment GC28 to the Mitchell and Whittlesea Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment implements the 'Donnybrook–Woodstock Precinct Structure Plan, October 2017' by incorporating the document into the Mitchell and Whittlesea Planning Schemes, inserting Schedules 4 and 6 to the Urban Growth Zone, applying overlays and making a number of other associated changes to the planning schemes to facilitate urban development and protect identified conservation areas within the precinct.

Amendment GC61

The Minister for Planning has approved Amendment GC61 to the Mitchell and Whittlesea Planning Schemes.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment incorporates the 'Donnybrook–Woodstock Metropolitan Greenfield Growth Area Standard Levy Infrastructure Contributions Plan, August 2017' into the Mitchell and Whittlesea Planning Schemes, introduces Schedule 1 to the Infrastructure Contributions Plan Overlay (ICPO1), and applies the ICPO1 to land within the Donnybrook–Woodstock Precinct Structure Plan area.
