- 63/2017      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 7 July 2018, it comes into operation on that day.
- 64/2017      (1) This Act (other than sections 5, 6, 14, 17 and 20) comes into operation on the day after the day on which this Act receives the Royal Assent.
- (2) Subject to subsection (3), sections 5, 6, 14, 17 and 20 come into operation on a day or days to be proclaimed.
- (3) If a provision referred to in subsection (2) does not come into operation before 1 August 2018, it comes into operation on that day.
- 65/2017      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 31 October 2018, it comes into operation on that day.
- 66/2017      (1) Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.
- (2) If a provision of this Act does not come into operation before 31 October 2018, it comes into operation on that day.
- 67/2017      (1) This Act (except Parts 2 to 10) comes into operation on the day on which it receives the Royal Assent.
- (2) Section 5 is taken to have come into operation on 1 July 2015.

**SPECIAL**

- (3) Part 6 comes into operation on 1 July 2018.
- (4) The remaining provisions of this Act come into operation on the day after the day on which this Act receives the Royal Assent.
- 68/2017      (1) This Chapter, Part 2.1, section 84 and Part 4.3 come into operation on the day on which this Act receives the Royal Assent.
- (2) Section 77 and Parts 2.8 (except section 84), 2.9, 2.10, 4.1, 4.4 and Chapter 5 come into operation on the day after the day on which this Act receives the Royal Assent.
- (3) Subject to subsections (4) and (5), the remaining provisions of this Act come into operation on a day or days to be proclaimed.
- (4) If section 4 or 5 or 7 to 30 or a provision of Part 2.3, 2.4 or Division 1 of Part 2.7 or section 72, 74, 75 or 76 or a provision of Chapter 3 or Part 4.2 does not come into operation before 1 November 2018, it comes into operation on that day.
- (5) If a provision referred to in subsection (3) (other other than a provision referred to in subsection (4)), does not come into operation before 1 January 2020, it comes into operation on that day.
