## Electricity Industry Act 2000

### ELECTRICITY LICENCE EXEMPTION FOR AGGREKO GENERATOR RENTALS PTY LTD

#### Order in Council

The Governor in Council under section 17 of the **Electricity Industry Act 2000** (the Act) makes the following Order:

1. Subject to paragraph 2, Aggreko Generator Rentals Pty Ltd (ABN 66 001 991 457) is exempt from the requirement to hold a licence to generate electricity under the Act.
2. This Order is subject to the following conditions:
  - a. Aggreko Generator Rentals Pty Ltd must only generate electricity at 412 Commercial Road, Morwell, Victoria 3840;
  - b. all electricity generated by Aggreko Generator Rentals Pty Ltd must be dispatched to the National Electricity Market;
  - c. Aggreko Generator Rentals Pty Ltd must comply with all applicable provisions of the:
    - National Electricity Law
    - National Electricity Rules
    - Electricity Distribution Code
    - Electricity System Code
    - any other codes, procedures or guidelines that are notified to it in writing by the Essential Services Commission as provisions applicable to Aggreko Generator Rentals Pty Ltd;
  - d. Aggreko Generator Rentals Pty Ltd must provide (whether or not through an agent), to the Minister for Energy, Environment and Climate Change or the Essential Services Commission, any information that either entity may reasonably require for the administration of this Order;
  - e. Aggreko Generator Rentals Pty Ltd must comply with the relevant requirements of the **Electricity Safety Act 1998** and any regulations made under that Act; and
  - f. Aggreko Generator Rentals Pty Ltd must have in place a system for monitoring compliance with this exemption, which is to the satisfaction of the Essential Services Commission.
3. This Order comes into operation on 27 December 2017.
4. This Order will continue in effect until 1 April 2018, unless otherwise revoked.
