#### Notice of Amendment of an Incorporated Document

Notice is given pursuant to section 112(2) of the Local Government Act 1989 that on 21 December 2017 the City of Port Phillip ('Council') made amendments to its Procedures and Protocols Manual 1 September 2013 ('Manual'), to designate that:

- Clause 54 of the City of Port Phillip Local Law (Community Amenity) 1 September 2013 ('Local Law') in respect to prohibiting the consumption and possession of liquor in certain circumstances, apply from 9.00 am on Tuesday 26 December 2017 to 8.00 pm on Thursday 4 January 2018 within the following areas along the foreshore areas within the City of Port Phillip:
  - North of Head Street, Elwood, and South of Ormond Esplanade between St Kilda Street, Elwood, and Glen Huntly Road, Elwood;
  - West of Marine Parade between Glen Huntly Road, Elwood, and Shakespeare Grove, St Kilda;
  - (iii) West of Jacka Boulevard, St Kilda, between Shakespeare Grove and Fitzroy Street;
  - (iv) West of Beaconsfield Parade between Fitzroy Street, St Kilda, and Esplanade East, Port Melbourne;
  - (v) West of Beach Street between Esplanade East, Port Melbourne, and Princes Street, Port Melbourne;
  - (vi) South of Waterfront Place, Port Melbourne, between the Port of Melbourne Authority and Princes Street, Port Melbourne;
  - (vii) South of Beach Street, Port Melbourne, between Princes Street and Beacon Cove; and
  - (viii) South of the Boulevard, Port Melbourne, between Beacon Cove and Todd Road.

Part 54, Alcohol Free Designated Areas, is amended to include the following:

A new provision Part 54.1(i):

'For the period from 9.00 am on Tuesday 26 December 2017 to 8.00 pm on Thursday 4 January 2018 along the foreshore areas within the City of Port Phillip:

- North of Head Street, Elwood, and South of Ormond Esplanade between St Kilda Street, Elwood, and Glen Huntly Road, Elwood;
- West of Marine Parade between Glen Huntly Road, Elwood, and Shakespeare Grove, St Kilda;
- (iii) West of Jacka Boulevard, St Kilda, between Shakespeare Grove and Fitzroy Street;
- (iv) West of Beaconsfield Parade between Fitzroy Street, St Kilda, and Esplanade East, Port Melbourne;
- (v) West of Beach Street between Esplanade East, Port Melbourne, and Princes Street, Port Melbourne;
- (vi) South of Waterfront Place, Port Melbourne, between the Port of Melbourne Authority and Princes Street, Port Melbourne;
- (vii) South of Beach Street, Port Melbourne, between Princes Street and Beacon Cove; and
- (viii) South of the Boulevard, Port Melbourne, between Beacon Cove and Todd Road.'

A new provision Part 54.2(b):

'For the period from 9.00 am on Tuesday 26 December 2017 to 8.00 pm on Thursday 4 January 2018 along the foreshore areas within the City of Port Phillip:

- (i) North of Head Street, Elwood, and South of Ormond Esplanade between St Kilda Street, Elwood, and Glen Huntly Road, Elwood;
- West of Marine Parade between Glen Huntly Road, Elwood, and Shakespeare Grove, St Kilda;
- (iii) West of Jacka Boulevard, St Kilda, between Shakespeare Grove and Fitzroy Street;
- (iv) West of Beaconsfield Parade between Fitzroy Street, St Kilda, and Esplanade East, Port Melbourne;
- (v) West of Beach Street between Esplanade East, Port Melbourne, and Princes Street, Port Melbourne;
- (vi) South of Waterfront Place, Port Melbourne, between the Port of Melbourne Authority and Princes Street, Port Melbourne;
- (vii) South of Beach Street, Port Melbourne, between Princes Street and Beacon Cove; and
- (viii) South of the Boulevard, Port Melbourne, between Beacon Cove and Todd Road.'



Pursuant to section 206 and Schedule 10, Clause 3 of the Local Government Act 1989, the Greater Dandenong City Council, at its ordinary meeting held on 14 August 2017, formed the opinion that part of Taylors Road, Dandenong South, shown cross-hatched on the plan below (Land), is not reasonably required as a road for public use and as such Council resolved to discontinue the road and to retain it and create the land as a reserve.

The Land is to be retained subject to any right, power or interest held by a public authority in the Land in connection with any sewers, drains, pipes, wires or cables under the control of the authority in or near the Land in particular in favour of South East Water and United Energy.



#### Meeting Procedure Law 2017

Pursuant to the Local Government Act 1989, Manningham City Council, at its meeting held on 12 December 2017, resolved to make the Meeting Procedure Law 2017.

The purpose and general purport of the Law is to:

- revoke the Meeting Procedure Law 2015;
- regulate and control the election of Mayor, Deputy Mayor and Council representatives on external bodies;

- regulate the use of the common seal;
- prohibit unauthorised use of the common seal or any device resembling the common seal;
- regulate proceedings and provide for the orderly and fair conduct of Council Meetings; and
- provide for penalties for non-observance of the provisions of the Law.

#### **EXEMPTION**

#### Application No. H298/2017

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Women's Health Grampians Inc. (the applicant). The application for exemption is to enable the applicant to:

- employ females only;
- provide services, including membership related services, to females only; and
- advertise these matters.

(together, the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Marianne Hendron, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- The applicant organisation is funded by the Department of Health and Human Services. It is a community based organisation run by women for women in the Grampians region of Victoria. The applicant's key purposes are to assist women on health issues and to respond to the needs of women who experience disadvantage and discrimination. There is a focus on the needs of women who have limited access to health services including Koori women, women from culturally and linguistically diverse backgrounds, women with disabilities and rural women. It seeks to improve the health and well-being of Victorian women through the development and dissemination of health information and research and through the provision of community and professional education.
- The applicant's services are wide ranging and include: leading and co-ordinating a prevention of violence regional plan which involves the delivery of workplace actions and strategies; providing training and education on matters including family violence awareness and prevention and gender equality to organisations including workplaces, schools, sporting clubs; research and consultancy on key areas of women's health with a focus on access and information for women in the most remote parts of the region as well as women from refugee or migrant backgrounds and women with disabilities; programs for the empowerment and inclusion of women such as programs which assist individual women to participate in economic and social life and develop their life skills.

- The services provided to members of the applicant organisation include access to programs and involvement in the running of the organisation.
- The applicant organisation is headed by a Chief Executive Officer. In addition, the applicant currently employs three full time employees and 10 part time employees. All staff are, from time to time, required to answer telephones or field enquiries from women seeking to use the service. It is appropriate that all staff are women so that clients can be confident that, when contacting the service, they will have their personal and confidential enquiries addressed by a woman. Having all female employees is also consistent with the services being provided to women by women and respect for the women's perspective being attributed the highest priority.
- On the evidence provided, I am satisfied that the services provided by the applicant direct to females who are seeking health and welfare information or who undertake programs which are designed to take account of particular needs and which are intended to assist them to better participate in economic and social life are special needs services under section 88 of the Act. That is because they meet the special needs of the applicant's female clients. I am further satisfied that the exception contained in section 28 of the Act applies in relation to those direct service provision aspects of the exempt conduct. That is because I am satisfied that the services where staff have direct and significant contact with the applicant's clients can be most effectively provided by female staff. However, the evidence does not establish that many of the applicant's other activities such as its policy, research and consultancy services, particularly when offered to other organisations, can be provided most effectively by females. Where I am not satisfied that an exception applies to the services provided by the holder of each role within the applicant organisation but accept that it is preferable that those services be provided by women only, it is appropriate that an exemption be granted. It is also appropriate to ensure that an organisation established to provide the kinds of services set out above, is able to, when appropriate, limit its services to females only.

- The applicant organisation was previously granted an exemption in like terms which expired on 31 October 2017 (A50/2012). In the absence of a further exemption, aspects of the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights** and **Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular the right to equal and effective protection against discrimination of males who would wish to be employed by the applicant or who would wish to access services as a client or member. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 16, 44, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 20 December 2022.



## 6. Periods when access is prohibited

The times during which access to the declared public safety zone is prohibited is the period of declaration.

## 7. Exempt persons or classes of person

Pursuant to section 5(2) of the Act, the following persons or classes of person are exempt from the operation of this declaration:

(a) Employees, agents and contractors of the Department of Environment Land Water and Planning engaged in carrying out their functions with authorisation from the Department of Environment, Land, Water and Planning Macalister District Manager.

### Proposed Firearms Regulations 2018

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared to assess the impact of the proposed Firearms Regulations 2018 (the proposed Regulations).

The proposed Regulations are to be made under the **Firearms Act 1996** (the Act). The Act principally governs the regulation of firearms in Victoria. In line with the Act, the overarching objective of the proposed Regulations is to promote public safety and peace, while balancing the needs of legitimate firearm users and owners.

The specific objectives of the proposed Regulations are to prescribe:

- fees for applications, issue and renewal of licences and for permits granted under the Act and for applications for review of decisions of the Chief Commissioner;
- devices that are excluded from the definition of 'firearm';

- the particulars to be entered on firearm dealers' and collectors' registers;
- offences in respect of which infringement notices may be issued;
- requirements for certain uses of firearms on private land;
- the manner in which searches without warrant may be conducted; and
- other matters necessary to give effect to the Act.

In relation to the fees provided by the proposed Regulations, the proposed fee schedule would: modify the fee structure and levels towards full cost recovery; maintain the primary production waiver; keep fees for junior licences, provisional licences and decision reviews at their existing levels; and introduce a discount for pensioners and the aged.

The RIS provides a number of fee options and non-fee options and examines the costs and benefits of the proposed Regulations and possible alternatives. These options are assessed against a number of criteria, with the RIS concluding that the proposed Regulations should be preferred.






