Control of Weapons Act 1990

DECLARATION OF DESIGNATED AREA UNDER SECTION 10D(1)

The Assistant Commissioner, North West Metro, acting as a delegate of the Chief Commissioner of Police under section 10D(1) of the **Control of Weapons Act 1990**, declares as a designated area in all public places within the City of Melbourne that is within the area bounded by and including, the intersection of Citylink and Footscray Road, to the intersection of Citylink and Westgate Freeway, to the intersection of Westgate Freeway and Clarendon Street, to the intersection of Clarendon Street and City Road, to the intersection of City Road and St Kilda Road, to the intersection of Alexandra Avenue and Olympic Boulevard, to the intersection of Olympic Boulevard and Batman Avenue, to the intersection of Batman Avenue and Flinders Street, to the intersection of Flinders Street and Spring Street, to the intersection of Spring Street and Victoria Street, to the intersection of Victoria Street and Peel Street, to the intersection of Peel Street and Dudley Street, to the intersection of Dudley Street and Footscray Road, to the intersection of Citylink and Footscray Road. For the removal of doubt this area includes Docklands, Federation Square, Parliament House, Flinders Street Railway Station, Melbourne Central Railway Station, Southern Cross Railway Station and Parliament Railway Station. (Road has the same meaning as in section 3 of the **Road Safety Act 1986**.)

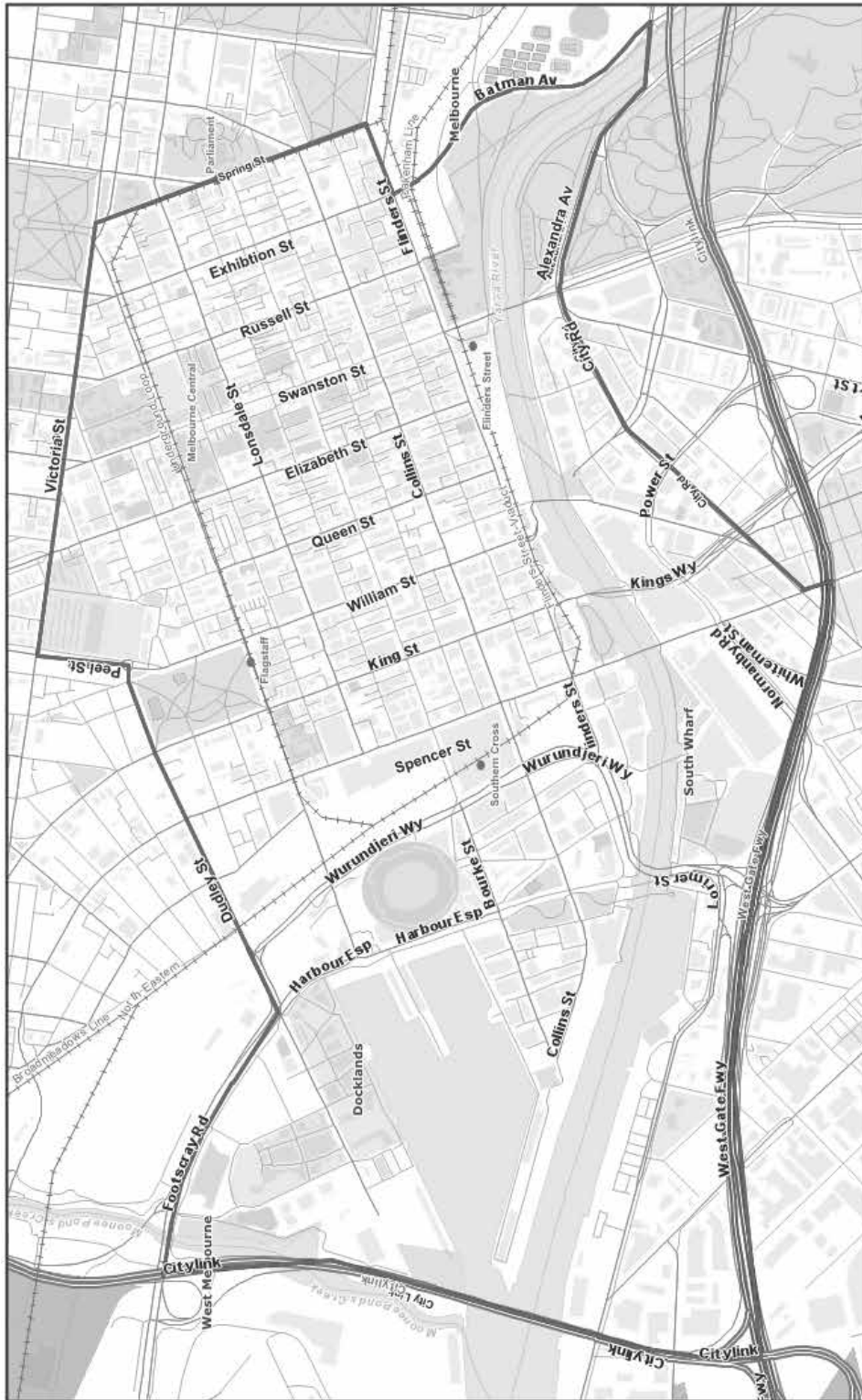

During these times members of the police force are authorised to exercise the following powers:

- (a) in a public place in the designated area, without warrant, stop and search for weapons:
 - (i) any person;
 - (ii) anything in the possession or control of the person;
 - (iii) any vehicle with a person in or on the vehicle; and
 - (iv) anything in or on such vehicle;
- (b) detain a person or vehicle for so long as is reasonably necessary to conduct a search;
- (c) seize and detain any item the member reasonably suspects is a weapon; and
- (d) request a person who is the subject of a full search to disclose his or her identity, and
- (e) direct a person to leave the designated area if the police officer reasonably believes the person is wearing the face covering primarily to
 - (i) conceal their identity; or
 - (ii) to protect them from the effects of a crowd control substance; andthe person refuses to remove the face covering when requested to do so.
- (f) direct the person to leave the designated area if the police officer reasonably believes the person intends to engage in conduct that would constitute an affray (section 195H **Crimes Act 1958**) or violent disorder (section 195I **Crimes Act 1958**).

The Assistant Commissioner, North West Metro, acting as a delegate of the Chief Commissioner of Police under section 10D(1) of the **Control of Weapons Act 1990**, declares as a designated area in all public places within the City of Port Phillip that is within the area bounded by and including, Dockside Drive and Port Phillip low tide mark, to the intersection of Empress Road and Webb Dock Drive, to the intersection of Empress Road and Webb Dock Drive, to the intersection of Todd Road and Williamstown Road, to the intersection of Todd Road and The Boulevard, to the intersection of The Boulevard and Beach Street, to the intersection of Beach Street and Beaconsfield Parade, to the intersection of Beaconsfield Parade and Fitzroy Street, to the intersection of Fitzroy Street and Princes Street, to the intersection of Princes Street and Barkly Street, to the intersection of Barkly Street and Blessington Street, to the intersection of Blessington Street and Marine Parade, Blessington Street to the Port Phillip Bay low tide mark, to the Port Phillip Bay low tide mark and Dockside Drive. For the removal of doubt this area includes Luna Park, St Kilda Pier, St Kilda Marina, the St Kilda Foreshore Reserve and Catani Gardens. (Road has the same meaning as in section 3 of the **Road Safety Act 1986**.)

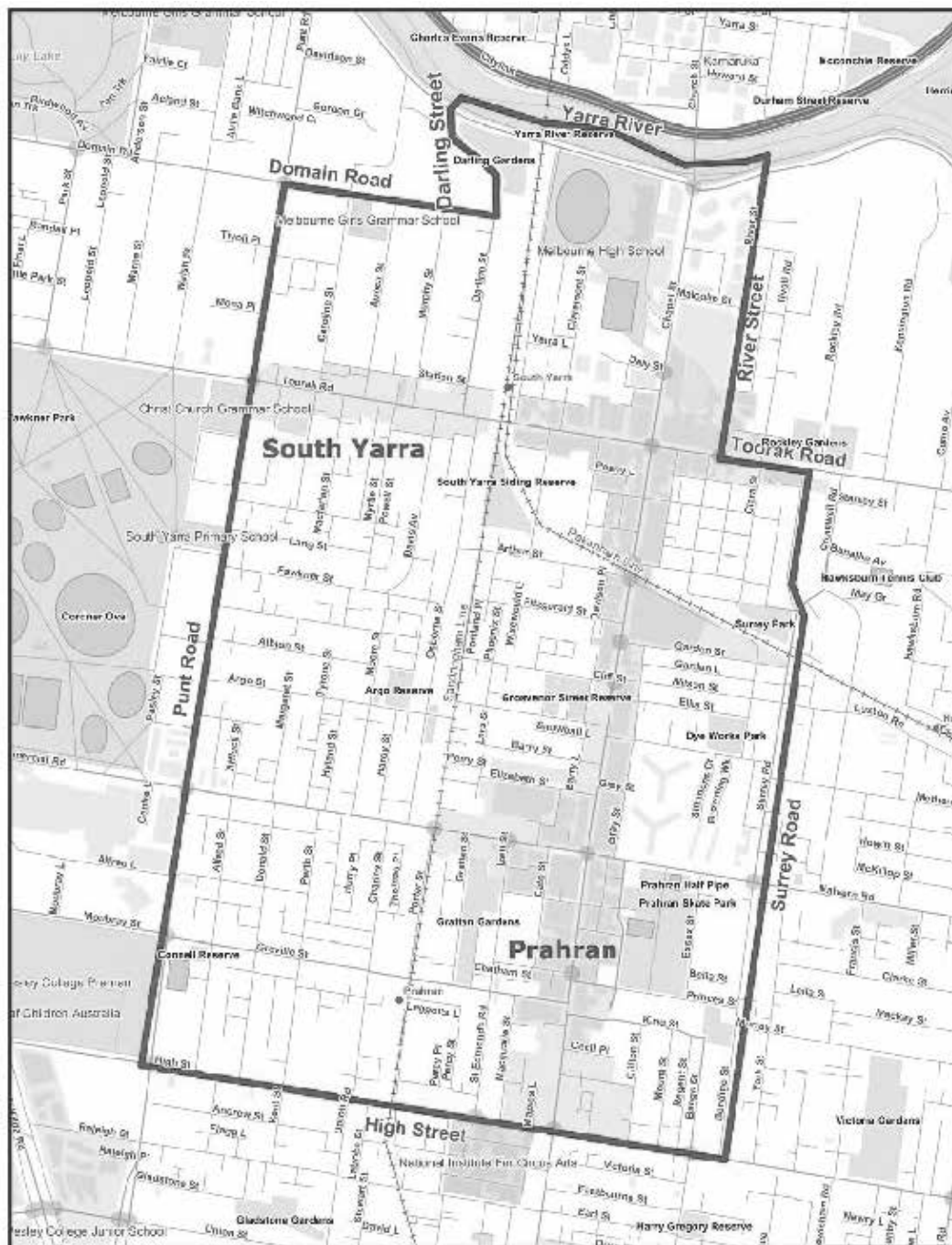

For the removal of doubt this area includes South Yarra Railway Station. (Road has the same meaning as in section 3 of the **Road Safety Act 1986**.)
