Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN FLINDERS FOR THE STEM FILM SHOOT ON 2 AND 3 FEBRUARY 2017

1 Purpose

The purpose of this Declaration is to exempt participants in the Stem Film Shoot from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on 2 and 3 February 2017.

2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

3 Commencement

This notice takes effect on 2 February 2017.

4 Expiry

This notice expires at 5.00 pm on 3 February 2017.

5 Definitions

In this notice, unless the context or subject matter otherwise requires –

- a) 'Event' means the Stem Film Shoot, to be held on 2 and 3 February 2017; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of the Stem Film Production Pty Ltd, whose presence is reasonably required to ensure the safe conduct of the Event.

6 Declaration

I, Anita Curnow, as delegate of the Minister for Roads and Road Safety, under section 99B(4) of the **Road Safety Act 1986** declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
