	(3)	If a provision referred to in subsection (2) does not come into operation before 1 January 2018, it comes into operation on that day.		
2/2017	(1)	This Act (except Parts 2 and 3) comes into operation on the day after the day on which this Act receives the Royal Assent.		
	(2)	Subject to subsection (3), Parts 2 and 3 come into operation on a day to be proclaimed.		
	(3)	If Parts 2 and 3 do not come into operation before 1 July 2018, they come into operation on that day.		
3/2017	(1)	Section 1 and this section come into operation on the day after the day on which this Act receives the Royal Assent.		
	(2)	Subject to subsection (3), the remaining provisions of this Act (including the items and provisions of items in Schedule 1) come into operation on a day or days to be proclaimed.		
	(3)	If a provision referred to in subsection (2) (including the items and provisions of
