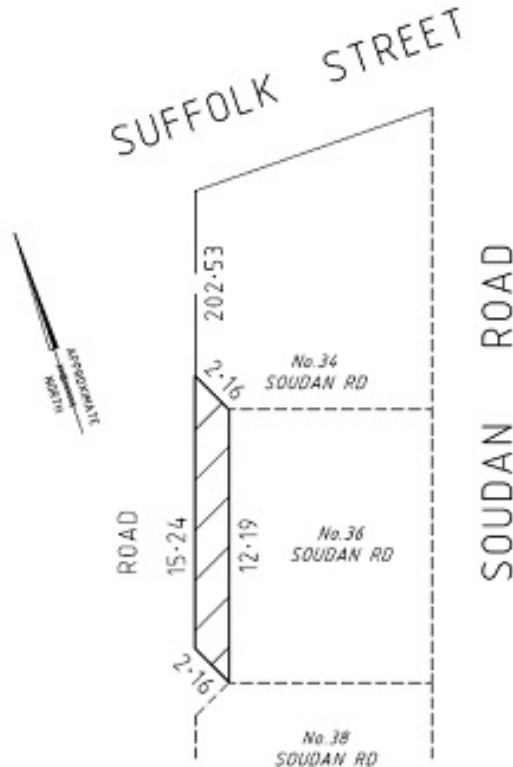

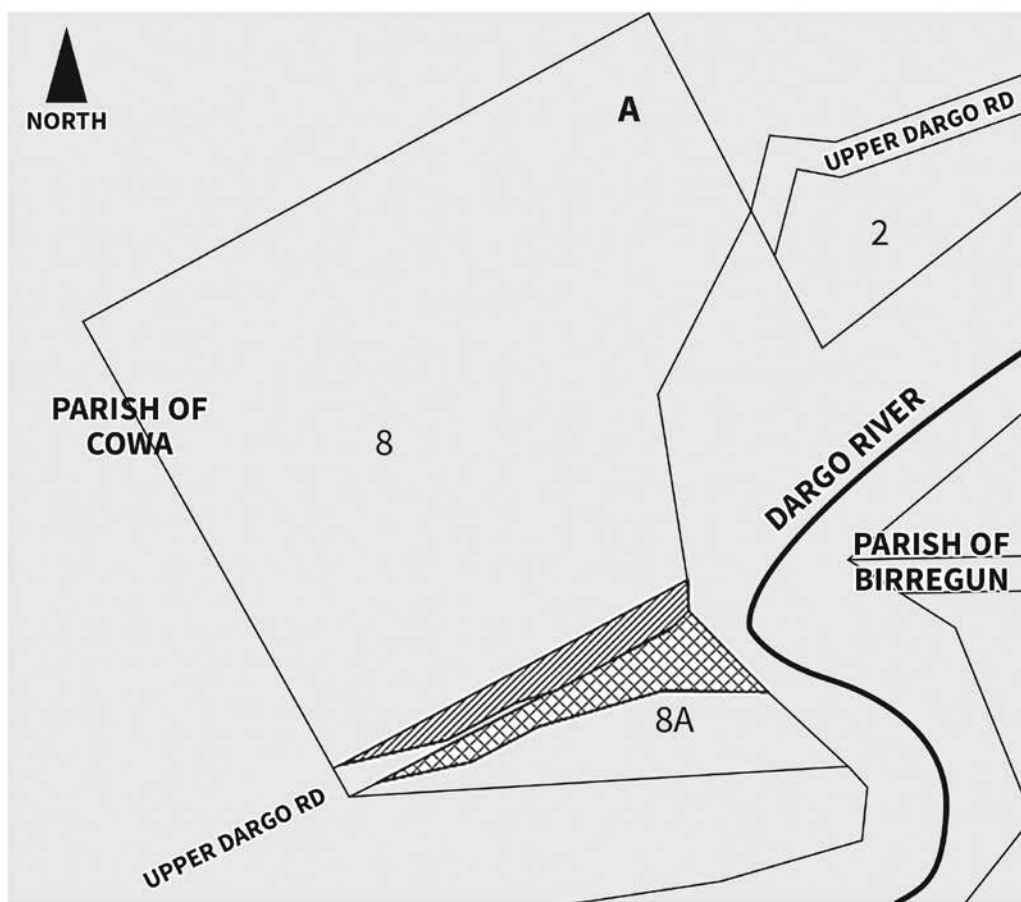

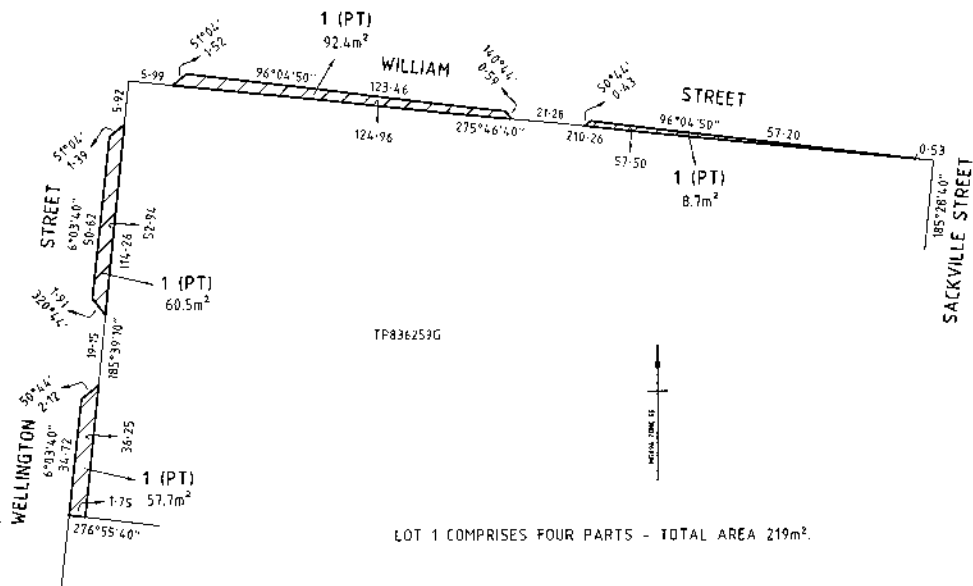

Pursuant to section 206 and Clause 3 of Schedule 10 to the **Local Government Act 1989**, Whittlesea City Council, at its Ordinary Meeting on 22 November 2016 and 7 February 2017, has resolved to formally discontinue four sections of road adjoining 60 Sackville Street, Mernda.

#### EXEMPTION

Application No. H273/2016

The Victorian Civil and Administrative Tribunal has considered an application pursuant to section 89 of the **Equal Opportunity Act 2010** (the Act) by Eaglehawk Bowling Club Inc. (the applicant). The application for exemption is to enable the applicant to organise and operate the following tournaments:

- (a) The Trevor O'Shea Memorial Triples (mixed tournament);
- (b) The Gold Letter Fours (men's tournament); and
- (c) The Ladies Invitational Annual Tournament (women's tournament),

and advertise these matters (the exempt conduct).

Upon reading the material filed in support of this application, including the affidavit of Con O'Shea, the Tribunal is satisfied that it is appropriate to grant an exemption from sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

In granting this exemption the Tribunal noted:

- A copy of the application was sent by the Tribunal to the Victorian Equal Opportunity and Human Rights Commission (the Commission). The Commission did not seek leave to intervene in the proceeding.
- The Trevor O'Shea Memorial Triples is next scheduled to run from Friday 21 April to Sunday 22 April 2017. The tournament commenced in 2002 as a men-only event. Since 2005 it has been run as a women-only tournament on the Friday and a men-only tournament on the Saturday and Sunday. Since 2008 the tournament has been



advertised as open to both genders but no women have entered to play on the Saturday/Sunday and no men have entered to play on the Friday. The mixed tournament has been sponsored over the years and sponsorship is now provided by a range of local businesses. The prize money is \$1,000 per day. No complaints have been received about the operation of the mixed tournament.

- The Gold Letter Fours honour board goes back to 1973 but it is likely to have been run since around when the applicant club was established in 1885. After 2008 the tournament was advertised as an open event but women have never entered. The applicant club wishes to run the tournament as a men-only event consistent with its history and place in club events. It is next scheduled to run on 1 November 2017. The men's tournament is sponsored and carries prize money of \$1,000.
- The Women's Annual Tournament has been run since at least around the 1970s. It is next scheduled to run in the first week of November 2017. In recent years it has been advertised as an open event but only women have entered to play. The applicant club also wish for this tournament to operate as a women's-only event consistent with its history and place in club events. The women's tournament is sponsored and carries prize money of \$500.
- The applicant club currently has 140 members of whom 66% are men and 34% are women. It runs mixed gender events throughout the week and runs mixed gender tournaments during the year. The club seeks to ensure that all members can play bowls in the way they prefer including by playing pennant, social bowls or being able to play in a social and inclusive environment. The club is concerned about dwindling and ageing female membership and takes that into account in scheduling events. It believes the separate scheduling of these three tournaments will benefit all club members.
- When considering whether to grant an exemption, the Tribunal must consider whether an exception in the Act already applies. The applicant has provided material which indicates that the exception contained in section 72(1B) of the Act applies. That exception allows a person to exclude people of one sex from participating in a competitive sporting activity or restrict participation in a competitive sporting activity to people of one sex if certain requirements are met. While noting that material, I am not satisfied that the evidence shows that each of the requirements of section 72(1B) is met. No current exemption already applies to the exempt conduct. In the absence of an exemption, the exempt conduct would amount to prohibited discrimination.
- When making decisions about exemptions, the Tribunal is required to give proper consideration to relevant human rights as set out in the **Charter of Human Rights and Responsibilities Act 2006** (Charter). Arguably, this exemption limits the right to equality and in particular, the right to equal and effective protection against discrimination of men or women who would wish to play in an event limited to the other gender. I am satisfied that, in the circumstances discussed above, the limit imposed by this exemption is reasonable and justified under the Charter.

The Tribunal hereby grants an exemption from the operation of sections 44, 71, 107 and 182 of the Act to enable the applicant to engage in the exempt conduct.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 15 February 2022.

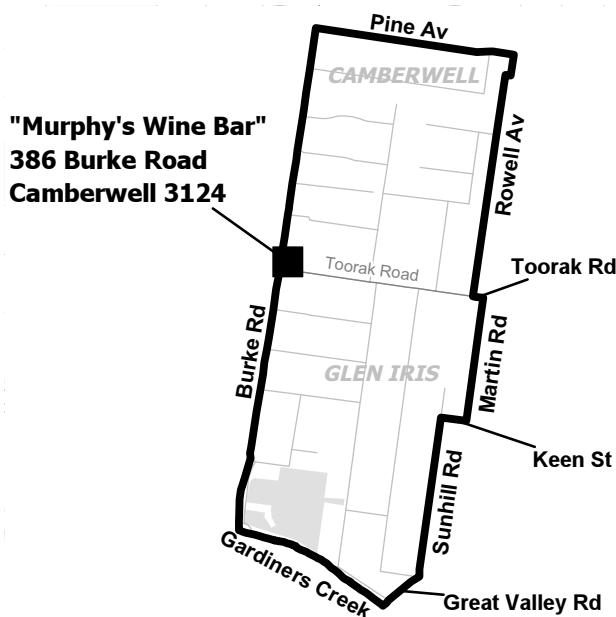

- A. The RICS Valuers Limited ('RISCV Limited') is a voluntary occupational association for valuers. It is a national organisation whose principal place of business is in Sydney, New South Wales.
- B. The RISCV Limited Scheme ('the scheme') commenced on 1 January 2016.
- C. This instrument of amendment has been prepared by the RISCV Limited under section 16A of the **Professional Standards Act 1994** (NSW) ('the Act') to amend the Scheme.

**AMENDMENT TO THE SCHEME**

This instrument to amend the scheme under section 16 of the Act is prepared by the RICSV, whose business address is Suite 1, Level 9, 1 Castlereagh Street, Sydney, New South Wales 2000. Amendments are as below.

**Persons to whom the scheme applies**

Clause 2.1: delete 'The scheme applies to all members of RICS Valuers Limited' and replace with 'The scheme applies to all members of RICSV Limited'.

Insert new clause 2.3 'Upon application by a member to whom the scheme applies, RICSV Limited may exempt the member from the scheme, provided that the scheme does not apply to the person by operation of section 18, 19 or 20 of the Act.'

**Limitation of liability**

Clause 3.2(a): delete 'of a kind which complies with the standards determined by the RICSV Limited' and replace with 'of a kind which complies with the RICSV Insurance Standards'.

Clause 3.3: insert the phrase 'in relation to a Valuation' thus 'The monetary ceiling (maximum amount of liability) in relation to a Valuation required for the purposes of limitation of liability under this scheme at the time at which the act or omission giving rise to the cause of action occurred is to be determined according to the following table'.

**Conferral of discretionary authority**

Clause 4.1: delete 'the RICS Valuers Limited' and replace with the defined term 'the RICSV Limited' thus 'Pursuant to section 24 of the Act, this scheme confers to the RICSV Limited a discretionary authority to specify, on application by a person to whom the scheme applies, in relation to that person a higher monetary ceiling (maximum amount of liability) not exceeding \$20 million, in relation to the person either in all cases or in any specified case or class of case.

**Definitions**

Clause 6.1: delete 'RICSV means the RICS Valuers Limited' and replace with 'RICSV Limited means the RICS Valuers Limited'.

Insert the phrase 'in any future amendments' in the definition 'Property Value' thus: '**Property Value** means the value of a property as at the date of the Valuation as determined under Market Value or as defined by the International Valuation Standards Council (IVSC) in any future amendments.'

Insert new definition '**Valuation** means an opinion or estimate of value made in writing by an individual member of RICSV Limited, or countersigned by an individual member of RICSV Limited pursuant to a client's written instructions.'

**COMMENCEMENT**

The amendments to the scheme made by this instrument will commence after publication in the appropriate Government Gazette(s).

**Professional Standards Act 1994 (NSW)****RICS Valuers Limited Scheme****PREAMBLE**

- A. The RICS Valuers Limited (RICSV Limited) is an occupational association.
- B. The RICSV Limited has made an application to the Professional Standards Council, constituted by the **Professional Standards Act 1994** (NSW) (the Act), for a scheme under the Act.
- C. The scheme is prepared by the RICSV Limited for the purposes of limiting occupational liability to the extent to which such liability may be limited under the Act.
- D. The RICSV Limited has furnished the Council with a detailed list of the risk management strategies intended to be implemented in respect of its members and the means by which those strategies are intended to be implemented.

- E. The scheme is intended to commence on 1 January 2016 and remain in force for five (5) years from its commencement unless, prior to that time, it is revoked, its operation ceases, or it is extended pursuant to section 32 of the Act.
- F. The scheme is intended to apply in New South Wales, Victoria, South Australia, the Australian Capital Territory, the Northern Territory, Queensland, and Western Australia.

## **RICS VALUERS LIMITED SCHEME**

### **1. Occupational association**

- 1.1 The RICS Limited Scheme (the scheme) is a scheme under the **Professional Standards Act 1994** (NSW) (the Act) prepared by the RICS Valuers Limited (RICS Limited) whose business address is: Suite 1, Level 9, 1 Castlereagh Street, Sydney, New South Wales 2000.

### **2. Persons to whom the scheme applies**

- 2.1 The scheme applies to all members of RICS Limited.
- 2.2 This scheme also applies to all persons to whom the scheme applied under clause 2.1 at the time of any act or omission giving rise to occupational liability.
- 2.3 Upon application by a member to whom the scheme applies, RICS Limited may exempt the member from the scheme, provided that the scheme does not apply to the person by operation of section 18, 19 or 20 of the Act.

### **3. Limitation of liability**

- 3.1 This scheme only affects the liability for damages arising from a single cause of action to the extent to which the liability results in damages exceeding \$1,000,000.
- 3.2 If a person, who was at the time of the act or omission giving rise to occupational liability, a person to whom the scheme applied, against whom a proceeding relating to occupational liability is brought, is able to satisfy the court that such person has the benefit of an insurance policy:
- of a kind which complies with the RICS Insurance Standards,
  - insuring such person against that occupational liability, and
  - under which the amount payable in respect of that occupational liability is not less than the monetary ceiling specified in this scheme,
- that person is not liable in damages in relation to that cause of action above the monetary ceiling specified in this scheme.
- 3.3 The monetary ceiling (maximum amount of liability) in relation to a Valuation required for the purposes of limitation of liability under this scheme at the time at which the act or omission giving rise to the cause of action occurred is to be determined according to the following table:

<b>Class</b>	<b>Description</b>	<b>Band</b>	<b>Monetary Ceiling</b>
1	Property Value A	\$0 million to < \$3 million	\$1 million
2	Property Value B	\$3 million to < \$5 million	\$2 million
3	Property Value C	\$5 million to < \$10 million	\$3 million
4	Property Value D	\$10 million to < \$20 million	\$4 million

For properties valued at above \$20 million the ceiling will be 20% of the value of the property on the day of the Valuation, up to \$10 million.

- 3.4 Clause 3.2 only affects liability for damages arising from a single cause of action to the extent to which the liability results in damages exceeding such amount as is specified in clause 3.1.
- 3.5 This scheme limits the occupational liability in respect of a cause of action founded on an act or omission occurring during the period when the scheme was in force of any person to whom the scheme applied at the time the act or omission occurred.



3.6 Notwithstanding anything to the contrary contained in this Scheme if, in particular circumstances giving rise to occupational liability, the liability of any person who is subject to this Scheme should be capped both by this Scheme and also by any other Scheme under Professional Standards Legislation (whether of this jurisdiction or under the law of any other Australian state or territory) and, if the amount of such caps should differ, then the cap on the liability of such persons arising from such circumstances which is higher shall be the applicable cap.

**4. Conferral of discretionary authority**

4.1 Pursuant to section 24 of the Act, this scheme confers to the RICSV Limited a discretionary authority to specify, on application by a person to whom the scheme applies, in relation to that person a higher monetary ceiling (maximum amount of liability) not exceeding \$20 million, in relation to the person either in all cases or in any specified case or class of case.

**5. Duration**

5.1 This scheme will be in force for a period of 5 years from the date of commencement.

**RICSV Insurance Standards** mean the insurance standards approved by the RICSV from time to time.

**The Act** means the **Professional Standards Act 1994** (NSW).

**Property Value** means the value of a property as at the date of the Valuation as determined under Market Value or as defined by the International Valuation Standards Council (IVSC) in any future amendments.

**Market Value** means the estimated amount for which an asset or liability should exchange on the valuation date between a willing buyer and a willing seller in an arm's length transaction, after proper marketing and where the parties had each acted knowledgeably, prudently and without compulsion or as defined by the International Valuation Standards Council (IVSC) in any future amendments.

**Valuation** means an opinion or estimate of value made in writing by an individual member of RICSV Limited, or countersigned by an individual member of RICSV Limited pursuant to a client's written instruction.

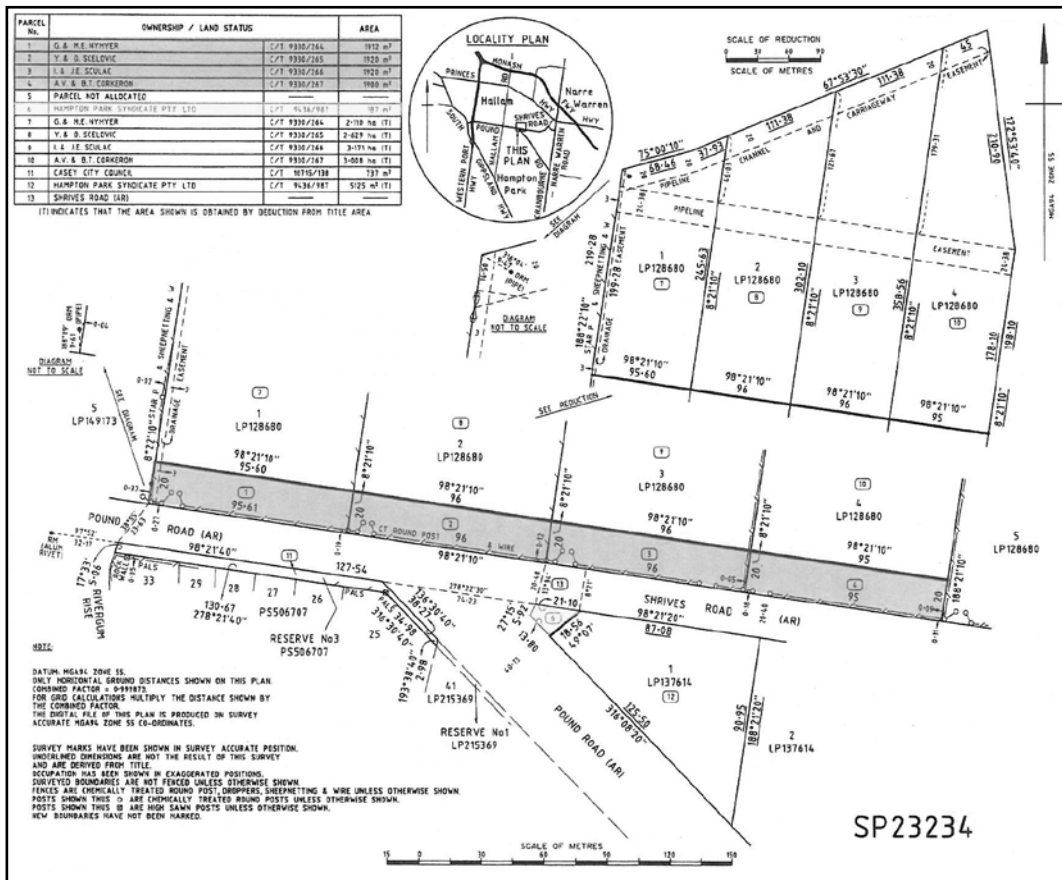

SCHEDULE TO THE ORDER IN COUNCIL

**1. Appointment Arrangements**

The members are appointed on a part-time basis.

**2. Period of Appointment**

The period of appointment is from the date of the Order in Council until 31 January 2020 (both dates inclusive).

**3. Duties and responsibilities of the position**

The functions and powers of the Adult, Community and Further Education Board (the Board) are provided under Division 2 of Part 3.3 of the **Education and Training Reform Act 2006** (the Act).

The functions of the Adult, Community and Further Education Board (the Board) include inquiring into and making reports on the development of policies, programs and services regarding providing adult, community and further education; planning, developing, evaluating and funding, policies, programs and services for the co-ordination, provision and support of adult, community and further education; providing for the delivery of adult, community and further education; and advising the Minister on any matter relating to adult, community and further education.



The Board also has certain financial powers, including the ability to make payments by way of grants, subsidies or loans in relation to adult, community and further education.

**4. Termination Arrangements**

Clause 2(3) of Schedule 2 to the Act, stipulates that the office of a member becomes vacant if the member becomes bankrupt, is found guilty of an offence which is, or which would if committed in Victoria be, an indictable offence or is absent from three consecutive meetings of the Board without the leave of the Chairperson or in the case of the Chairperson without the Minister's leave.

**5. Payment Provisions**

Under clause 3(1) of Schedule 2 to the Act the members of the Board, other than a member who holds a full-time Government office, or a full-time position in the public service, teaching service or with a statutory authority (other than a university), are entitled to receive the remuneration and fees that are fixed in the member's instrument of appointment or are fixed from time to time by the Governor in Council.

The remuneration for eligible Board members (including the Deputy Chairperson) is fixed at the sessional fee of \$414 per full day or \$207 per half day Board commitment. Helen Coleman, John Maddock, Andrea McCall, Winifred Scott, Penny Wilson and Ronald Wilson are eligible for remuneration.

To avoid doubt, in accordance with clause 4(3) of Schedule 2 to the Act, a person appointed to act in the place of a member, including a Chairperson, is entitled to the remuneration and allowances (if any) to which the member for whom he or she is acting would have been entitled for performing those duties.

**6. Superannuation Obligations**

Superannuation will be paid in accordance with the **Superannuation Guarantee (Administration) Act 1992**.

**7. Travel and Personal Expenses arrangements**

Under clause 3(2) of Schedule 2 to the Act the members of the ACFE Board are entitled to receive the personal and travelling expenses that are fixed in the member's instrument of appointment or are fixed from time to time by the Governor in Council. Board members are entitled to reimbursement of reasonable travelling and personal expenses incurred consistent with the policies of the Department of Education and Training.

**8. Leave Arrangements**

There are no leave provisions for these part-time statutory positions.

**9. Prior Service**

Prior service is not applicable for long service or leave entitlement.
