Notice of Preparation of Amendment

#### Amendment C126

The Bayside City Council has prepared Amendment C126 to the Bayside Planning Scheme. The land affected by the Amendment is a number of small activity centres throughout the Bayside municipality.

The Amendment proposes to implement the recommendations and policy of the 'Bayside Small Activity Centres Strategy 2014' by amending the Local Planning Policy Framework and applying Schedule 13, Schedule 14, Schedule 15, Schedule 16 and Schedule 17 to the Design and Development Overlay.

The Amendment specifically proposes to:

- 1. update the following clauses contained within the Municipal Strategic Statement:
  - Clause 21.02 Bayside Key Issues and Strategic Vision;
  - Clause 21.06 Built Environment and Heritage;
  - Clause 21.07 Economic Development;
  - Clause 21.11 Local Areas;
- apply the Design and Development Overlay to land within a number of small activity centres to guide Council's decision making in relation to the desired role and built form within these centres;

#### 7. Travel and Personal Expenses arrangements

Under schedule 2, section 3(2) of the Act, each member or acting member of the Authority is entitled to receive the personal and travelling expenses that are fixed in the member's instrument of appointment or are fixed from time to time by the Governor in Council for that member. Reasonable travel and personal expenses will be paid in accordance with normal public service practice and policy.
