NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT

Proposed Retirement Villages (Contractual Arrangements) Regulations 2017

Notice is given in accordance with section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared for the Retirement Villages (Contractual Arrangements) Regulations 2017.

The proposed Regulations, to be made under the **Retirement Villages Act 1986**, would remake the Retirement Villages (Contractual Arrangements) Regulations 2006.

The objectives of the Retirement Villages (Contractual Arrangements) Regulations 2017, are to:

- provide for the terms that a village operator can include in residence contracts giving non-owner residents control over the re-leasing of their units and enabling the operator to avoid having to pay the exit entitlement before the unit has been re-leased
- require retirement village operators, on request from a leasehold resident, to pay their aged care accommodation costs if, 6 months after the resident has gone into aged care, the resident's unit has not been re-leased
- stipulate prescribed terms that are incorporated into certain residence contracts allowing for the independent valuation of a resident's unit or, as the case may be, an indexation formula, for the purpose of estimating the resident's exit entitlement where it is based on the next ingoing contribution, and
- stipulate matters that must and must not be included in residence and management contracts, certain prescribed terms of residence and management contracts and standard layouts for residence and management contracts.

The RIS examines the costs and benefits of the proposed Regulations and possible alternatives, and concludes that the proposed Regulations are the most efficient method of achieving the objectives.
