



Control of Weapons Act 1990

DECLARATION OF DESIGNATED AREA UNDER SECTION 10D(1)

The Assistant Commissioner, Transit and Public Safety Command, acting as a delegate of the Chief Commissioner of Police under section 10D(1) of the **Control of Weapons Act 1990**, declares as a designated area in all public places within the area bounded by and including, the intersection of Spring Street and Victoria Street to the intersection of Victoria Street and Peel Street, to the intersection of William Street and Dudley Street, to the intersection of Dudley Street and Spencer Street, to the intersection of Spring Street, the continuation of Whiteman Street, to the intersection of Whiteman Street and City Road, to the intersection of City Road and St Kilda Road, to the intersection of St Kilda Road and Linlithgow Avenue, to the intersection of Linlithgow Avenue and Alexandra Avenue, to the intersection of Street, the intersection of Clympic Boulevard and Batman Avenue, the continuation into Exhibition Street, the intersection of Exhibition Street and Flinders Street, to the intersection of Flinders Street. For the removal of doubt this area includes Federation Square, Birrarung Marr, Alexandra Gardens, Flinders Street Railway Station and Melbourne Central Railway Station.as shown on the map below. (Road has the same meaning as in section 3 of the **Road Safety Act 1986**.)



This declaration will operate on:

Friday 10 March 2017 from 4.00 pm to Saturday 11 March 2017 at 4.00 am; Saturday 11 March 2017 from 4.00 pm to Sunday 12 March 2017 at 4.00 am; Sunday 12 March 2017 from 4.00 pm to Monday 13 March 2017 at 4.00 am; and Monday 13 March 2017 from 10.00 am to 10.00 pm.

SPECIAL

During these times members of the police force are authorised to exercise the following powers: (a)

- in a public place in the designated area, without warrant, stop and search for weapons:
 - any person; (i)
 - (ii) anything in the possession or control of the person;
 - (iii) any vehicle with a person in or on the vehicle;
 - (iv) anything in or on such vehicle;
- detain a person or vehicle for so long as is reasonably necessary to conduct a search; (b)
- (c) seize and detain any item the member reasonably suspects is a weapon; and
- request a person who is the subject of a full search to disclose his or her identity. (d)
