	(2)	If a provision of this Act does not come into operation before 1 October 2017, it comes into operation on that day.			
16/2017	(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.			
	(2)	If a provision referred to in subsection (1) does not come into operation before 15 December 2017, it comes into operation on that day.			
17/2017	(1)	This Act comes into operation on the day after the day on which it receives the Royal Assent.
