Building Regulations 2017

Notice is given under section 11 of the **Subordinate Legislation Act 1994** that a Regulatory Impact Statement (RIS) has been prepared in relation to the Building Regulations 2017 (the proposed Regulations). The proposed Regulations are to be made under the **Building Act 1993**. Public comment is invited.

Reason for and objectives of the proposed Regulations

The proposed Regulations are intended to replace the existing Building Regulations 2006 which sunset on 5 June 2017 in accordance with regulation 3 of the Subordinate Legislation (Building Regulations 2006) Extension Regulations 2016.

The objectives of the proposed Regulations are:

- (a) to remake with amendments the regulations which control the design, construction and use of buildings and places of public entertainment; and
- (b) to prescribe standards for the construction and demolition of buildings; and
- (c) to prescribe standards of safety for places of public entertainment; and
- (d) to regulate matters relating to the use and maintenance of buildings and places of public entertainment; and
- (e) to prescribe requirements for the design and siting of single dwellings and associated buildings; and
- (f) to prescribe standards and matters relating to the maintenance of fire safety and safety measures; and
- (g) to prescribe requirements for swimming pool and spa safety; and
- (h) to provide for matters relating to the accreditation of building products, construction methods, designs, components and systems connected with building work; and
- to prescribe qualifications and provide for other matters relating to registration of building practitioners; and
- to prescribe fees in relation to matters before the Building Appeals Board, the Authority and the Building Regulations Advisory Committee; and
- (k) to provide for other matters for the purposes of the **Building Act 1993**.

Summary of the results of the regulatory impact statement

The RIS assesses the costs and benefits of the proposed Regulations and alternative options. The RIS concludes that the proposed Regulations are the best means of meeting the objectives of the Regulations. The Proposed Regulations largely remake and update the current Building Regulations 2006, but also introduce a number of substantive changes to improve consumer protection and safety.

 - (iv) the Cowwarr Main Channel;

 - (1) In clause 1(a) of Schedule 3A of the Bulk Entitlement, for 'long term' **substitute** 'long-term'.

 - '(b) describe the actions to be taken by Southern Rural Water to quantify and comply with the diversion limit; and'.

- (b) The method for preparing model input files is to be documented. The documentation forms part of the compliance reporting.
- 5.3 Step 2: Calculate annual target diversion volume
 - (a) The annual target diversion volume for the year just ended is determined by running the approved diversion limit model from July 2008 to June of the year just ended, with:
 - (i) the model input files as updated in Step 1; and
 - (ii) the storage starting volumes of Lake Glenmaggie and Thomson Reservoir recorded on 1 July 2008.
 - (b) The annual target diversion volume is the sum of the volumes that would have been diverted from the Thomson/Macalister system under this Order under baseline conditions, as calculated by the model where the diversion components are –
- = The sum of all diversions to supply primary entitlements:
 - = Release from Lake Glenmaggie to the Main Northern Channel
 - + Release from Lake Glenmaggie to the Main Southern Channel
 - + Release from Lake Glenmaggie to the Cowwarr Main Channel
 - + Release from Maffra Weir to the Main Eastern Channel
 - Release from the Southern Channel to the Thomson River

(The above releases include diversions for irrigation, system distribution losses, that part of town supplies taken from Southern Rural Water's channels, and domestic and stock water within irrigation districts.)

- + The sum of all volumes pumped to supply primary entitlements directly from:
 - Lake Glenmaggie;
 - the Macalister River between Lake Glenmaggie and the Thomson River
 - Thomson Reservoir;
 - the Thomson River between Thomson Reservoir and the Latrobe River; and
 - Rainbow Creek.
- + Regulated urban bulk entitlements = the volumes diverted directly from the river by Gippsland Water¹ to supply its towns (includes Heyfield, Maffra/Stratford, Coongulla, Glenmaggie and other small towns).
- Any credits granted to Southern Rural Water by the Minister under clause 17 of the Order.
- The volume of any water that is returned to the water system in accordance with a condition in a licence issued under section 51 of the Act.

Note 1: Supply to some towns is partly from channels (accounted for by Southern Rural Water) and partly from the river (accounted for by Gippsland Water).

- (c) The annual target diversion volume is to be adjusted by:
 - (i) subtracting the final volumetric allocation against the environmental entitlements listed in Schedule 1; and
 - (ii) making adjustments as required for sub-clause 6.3; and
 - (iii) making any other necessary adjustments as required in consultation with the Department.
- 5.4 Step 3: Calculate the annual measured diversion volume

The annual measured diversion volume for the year just ended is the sum of the measured volumes taken from the system at the locations detailed in Step 2, including Step 2 (c) (ii).

5.5 Step 4: Calculate the cumulative departure from the estimated long-term average annual diversion volume

The cumulative departure from the estimated long-term average annual diversion volume is –

- (a) expressed as a volume:
- = The sum of the differences between the annual target diversion volume and the annual measured diversion volume from 2008/09 to date in ML.

and

(b) expressed as a percentage:

= [The sum of the differences between the annual target diversion volume and the annual measured diversion volume from 2008/09 to date in ML] x 100

[The estimated long-term average annual diversion in ML]

Where:

The estimated long-term average annual diversion is the average annual modelled diversion between July 1955 and June 2004.

(4) In clause 6.1 of Schedule 3A of the Bulk Entitlement, for 'long term average annual diversion volume is greater than +20%,' **substitute** 'long-term average annual diversion volume is in debit by greater than 20%,'.



TRANSPORT ACCIDENT CHARGES ORDER (NO. 1) 2017

Order in Council

The Governor in Council under section 110(8) of the **Transport Accident Act 1986** on the recommendation of the responsible Minister makes the following Order:

This Order will come into effect from 1 July 2017.

1. Title

916

This Order is called the Transport Accident Charges Order (No. 1) 2017.

2. Commencement

This Order comes into operation on 1 July 2017.

3. Definitions

In this Order -

'exempt general-use motorcycle' means a general-use motorcycle which, -

- (a) at the time when application is made for registration or renewal of registration, application is made by a person who has another general-use motorcycle registered under the **Road Safety Act 1986** that is classified under 3(a)(iii) or 3(a)(iv) of Schedule 1 to this Order, and
- (b) is fitted with an engine with a capacity greater than 125 cc, and
- (c) is the subject of an application for registration or renewal of registration by an individual;

'general-use motorcycle' means a motorcycle that is not classified, or to be classified, under 4(b), 4(c), 4(d), 5(b)(ii) or 5(d) of Schedule 1 to this Order;

'high risk zone' means the parts of the State in which addresses are allocated a postcode listed in Part A of Schedule 2 and, except if the Commission otherwise determines under 110(1A) of the Act, any place outside Victoria;

'low risk zone' means the parts of the State that are not located in the 'high risk zone' or the 'medium risk zone';

'medium risk zone' means the parts of the State in which addresses are allocated a postcode listed in Part B of Schedule 2 to this Order;

'nominated motor vehicle' means a motor vehicle in respect of which the applicant for registration or renewal of registration has nominated a period of six months as the registration period in accordance with regulation 43(1) or regulation 68(1) of the Road Safety (Vehicles) Regulations 2009;

'nominated pensioner motor vehicle' means a 'pensioner motor vehicle' in respect of which the pensioner has nominated a period of six months as the registration period in accordance with regulation 43(1) or regulation 68(1) of the Road Safety (Vehicles) Regulations 2009;

'pensioner motor vehicle' means a motor vehicle that -

- (a) is registered or to be registered in the name of an eligible pensioner within the meaning of the **State Concessions Act 2004**; and
- (b) is eligible to be registered under the **Road Safety Act 1986** in accordance with regulation 102(2) or item 10, 11, 12 and 13 of the Table to Schedule 3 to the Road Safety (Vehicles) Regulations 2009; and
- (c) is registered or about to be registered under the **Road Safety Act 1986**;

'prescribed period' means the period prescribed for the purposes of section 109 of the Act in relation to a motor vehicle of a certain class specified in regulation 5 of the Transport Accident (Administration of Charges) Regulations 2001;

'the Act' means the Transport Accident Act 1986.

'declared apprentice's concession' means a 50 per cent discount on the TAC charge payable for a vehicle registered under the **Road Safety Act 1986** and classified under category 1(a), 1(b)(i), 2(a) or 2(b) of this Order, in the name of a declared apprentice within the meaning of Regulation 5 of the Road Safety (Vehicles) Regulations 2009.

4. Transport accident charge

- 1. The amount of the transport accident charge applicable to a motor vehicle, other than a pensioner motor vehicle, for which the prescribed period is 12 months is the amount shown in Schedule 1 as applicable in respect of
 - (a) motor vehicles of that class; and
 - (b) the high risk zone, medium risk zone or low risk zone, as the case may be, in which the motor vehicle is usually kept.
- 2. If the prescribed period in relation to a motor vehicle, other than a nominated motor vehicle or a nominated pensioner motor vehicle, is less than 12 months, the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –

$$\frac{(A \times B)}{365} + $17$$

where -

- A is the amount of the transport accident charge applicable under sub-paragraph (1); and
- B is the number of days in the prescribed period.
- 3. Despite sub-paragraph (2), if the prescribed period in relation to a motor vehicle, other than a nominated motor vehicle or a nominated pensioner motor vehicle, is less than 12 months, and is a whole number of months, the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –

$$(A \times C) + $17$$

where -

- A is the amount of the transport accident charge applicable under sub-paragraph (1); and
- C is the number of months in the prescribed period.
- 4. If the prescribed period in relation to a motor vehicle is more than 12 months, the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –

where -

- A is the amount of the transport accident charge applicable under sub-paragraph (1); and
- B is the number of days in the prescribed period.

5. Despite sub-paragraph (4), if the prescribed period in relation to a motor vehicle is more than 12 months and is a whole number of months, the transport accident charge applicable to the motor vehicle in respect of that period is the amount, calculated to the nearest whole dollar, determined in accordance with the formula –

(A x C)

where -

- A is the amount of the transport accident charge applicable under sub-paragraph (1); and
- C is the number of months in the prescribed period.
- 6. If the motor vehicle is a pensioner motor vehicle the transport accident charge applicable to the motor vehicle is one-half of the transport accident charge that would otherwise be payable.
- 7. If the motor vehicle is a nominated pensioner motor vehicle the transport accident charge applicable to the motor vehicle is one-quarter of the amount shown in Schedule 1 as applicable in respect of
 - (a) motor vehicles of that class; and
 - (b) the high risk zone, medium risk zone or low risk zone, as the case may be, in which the motor vehicle is usually kept,

rounded down to the nearest fifty cents.

- 8. If the motor vehicle is a nominated motor vehicle, the transport accident charge applicable to the motor vehicle is one-half of the amount shown in Schedule 1 as applicable in respect of
 - (a) motor vehicles of that class; and
 - (b) the high risk zone, medium risk zone or low risk zone, as the case may be, in which the motor vehicle is usually kept,

rounded down to the nearest fifty cents.

- 9. If the motor vehicle is subject to the 'declared apprentice's concession' the transport accident charge applicable to the motor vehicle is one-half of the transport accident charge that would otherwise be payable for motor vehicle's classified under class' 1(a), 1(b)(i), 2(a) or 2(b),
- 10. In the case of a motor vehicle referred to in item 1(c) in Schedule 1, the motor vehicle is deemed to be usually kept in the zone in which it is licensed to operate or, if it is licensed to operate in more than one zone, the zone in respect of which the greater transport accident charge applies.


