## Planning and Environment Act 1987

Section 7(5)

## MINISTERIAL DIRECTION

- I, Richard Wynne, Minister for Planning, approve the Ministerial Direction on the Form and Content of Planning Schemes prepared under section 7(5) of the **Planning and Environment Act** 1987 as follows:
- 1. Amend paragraph 3 to include Clause 1 Preliminary and Clause 2 User guide
- 2. Amend paragraph 3 to include Clause 20, 53, 57 and 75 of the VPP
- 3. Amend paragraphs 6 to 10 to improve the requirements. This includes numeric terminology and requirements for images in scheme ordinance
- 4. Include a requirement for **Clause 21**, **Municipal strategic statement** to be included in a planning scheme where the municipal council is the planning authority
- 5. Include the requirement that **Clause 22** be used for the local planning policies in a planning scheme
- 6. Amend the **Annexure 1 Style Guide** to include new format and text styles
- 7. Amend **Annexure 2** to:
  - Include additional guidance (in blue text) within schedules to assist planning authorities and other users to better interpret and draft schedules
  - Correct the schedule to Clause 35.05 Green Wedge A Zone to remove incorrect reference to the land use term 'Residential hotel' and replace with 'Residential building'
  - Correct Clause number references for Clause 52.05 Advertising signs
  - Merge the two schedules to Clause 52.28 Gaming into one schedule
  - Various changes to ensure the requirements in schedules are derived from the head of power provided in the VPP provisions
- 8. Delete the **Annexure 3 Earth and Energy Resources Schedule.** The schedule is no longer required
- 9. Annexure 4 SPPF A planning scheme must include clauses 11–11.05 of the State Planning Policy Framework and prescribed sub-clauses.
