## Road Management Act 2004

### ROAD DECLARATIONS AND DISCONTINUANCES

#### ROAD DECLARATIONS

VicRoads, pursuant to sections 11 and 14 of the **Road Management Act 2004**, upon publication of this notice declares, revokes or renames the roads described in Schedule A and on the plans attached.

VicRoads also authorises and withdraws the freeway access points described in Schedule B and on the plans attached.

#### ROAD DISCONTINUANCES

VicRoads, pursuant to section 12 of the **Road Management Act 2004**, upon publication of this notice:

- a) discontinues the parts of Hume Freeway described in Schedule C and on the plans attached, subject to the right, power and interest held by the Authority/Beneficiary over the Identified Land shown in Schedule D and on the plan attached, as provided for in section 207C of the **Local Government Act 1989**; and
- b) approves the sale of the surplus land as provided in section 94 of the **Transport Integration Act 2010** and as delegated by the Minister for Roads and Road Safety under section 31 of the latter said Act.
- c) discontinues the parts of South Gippsland Highway described in Schedule C and on the plan attached

The effects of these Road Declarations and Road Discontinuances on road names are described in Table 1.

### SCHEDULE A

#### FREEWAY

- a) Those parts of Hume Freeway identified by hatching on the plans numbered GP23483 and GP23483A are revoked as described in the legend in the said plans.
- b) Those parts of Western Freeway identified by hatching on the plans numbered GP22055, GP22056, GP22058, GP22060, GP22061 and GP22062 are declared as described in the legend in the said plans.

#### ARTERIAL ROAD

- c) Those parts of South Gippsland Highway identified by hatching on the plan numbered GP22391 are declared or revoked as described in the legend in the said plan.
- d) Those parts of Dandenong Bypass identified by hatching on the plans numbered GP21926, GP21927, GP21928, GP21929, GP21930, GP21931, GP21932, GP21933 and GP21934 are declared or renamed as described in the legend in the said plans.
- e) Those parts of State (Bell/Springvale) Highway identified by hatching on the plans numbered GP21926 and GP21927 are declared as described in the legend in the said plans.
- f) Those parts of State (Lower Dandenong/Cheltenham) Highway identified by hatching on the plans numbered GP21929, GP21930 and GP21934 are declared as described in the legend in the said plans.

#### MUNICIPAL ROAD

- g) Those parts of Jeetho Road identified by hatching on the plan numbered GP22391A are declared as described in the legend in the said plan.
- h) That part of Coomoora Road identified by hatching on the plan numbered GP21926A is declared as described in the legend in the said plan.

**SPECIAL**

- i) That part of Southpark Close identified by hatching on the plan numbered GP21927A is declared as described in the legend in the said plan.
- j) That part of Perry Road identified by hatching on the plan numbered GP21934A is declared as described in the legend in the said plan.
