





## Amendment C94

## PART 1 – PRELIMINARY

## 1 Objectives

The objectives of these Regulations are to provide for the -

- (a) care, protection and management of the reserve; and
- (b) safety of persons in the reserve.

## 2 Authorising provision

These Regulations are made under section 13 of the Crown Land (Reserves) Act 1978.

### 3 Commencement

These Regulations come into operation on the day on which they are published in the Government Gazette.

## 4 Expiry

These Regulations expire on the day that is 10 years after the day on which they come into operation.

## 5 Definitions

In these Regulations -

the Act means the Crown Land (Reserves) Act 1978; Parks Victoria has the same meaning as in the Parks Victoria Act 1998;

Minister means the Minister administering the Crown Land (Reserves) Act 1978;

racehorse means a horse trained or kept for racing for a commercial benefit;

**Reserve** means the land shown hatched on the plan lodged in the Central Plan Office and numbered LEGL./17-373.

## 6 Application of Regulations to permit, lease or licence holders etc.

These Regulations do not apply, to -

- (a) a person who is acting under and in accordance with the terms and conditions of any permit, lease, licence or other authority granted under the Act, or
- (b) a person who is acting under and in accordance with the terms and conditions of any agreement entered into under the Act.

## 7 Application of Regulations to employees etc.

These Regulations do not apply to any of the following persons if that person is carrying out their duties or functions –

- (a) an employee of Parks Victoria;
- (b) an authorised officer;
- (c) a police officer;
- (d) a contractor, agent, volunteer or other person carrying out any work for or acting on the authority or instruction of the Secretary, the Minister or Parks Victoria;
- (e) a person employed under Part 3 of the **Public Administration Act 2004** who is carrying out a duty or function under a relevant law within the meaning of the **Conservation, Forests and Lands Act 1987**;

- (f) an operational staff member within the meaning of the Ambulance Services Act 1986;
- (g) an officer, employee or volunteer emergency worker of an emergency services agency when engaged in an emergency activity or the discharge of a responsibility, function or other role in relation to an emergency.

## PART 2 – ADMINISTRATION OF ACCESS TO THE RESERVE

## 8 Determination setting aside area for certain purposes

- (1) The Minister may, by written determination, set aside an area in the reserve
  - (a) as an area in which specified activities are restricted; or
  - (b) as an area in which specified activities are prohibited.
- (2) The Minister must cause signs or notices informing the public of the determination to be erected or displayed at the areas affected by the determination.
- (3) The Minister must not make a determination under subregulation (1) unless the Minister considers the determination is necessary for the purposes of
  - (a) the care, protection and management of the reserve; or
  - (b) the safety of persons in the reserve.
- (4) A determination made under this regulation may specify
  - (a) whether the determination applies to the whole or a specified part of the reserve; and
  - (b) the days, times or periods during which the specified activity is restricted or prohibited in a reserve or a part of the reserve to which the determination applies; and
  - (c) if applicable, the class of person to which the determination applies.
- (5) If a determination is made under subregulation (1) and a sign or notice is erected or displayed in accordance with subregulation (2), a person must comply with the conditions of that determination.
  - Penalty: 10 penalty units

## 9 Signs

- (1) A sign or notice required under these regulations must
  - (a) be displayed in a place and manner that is likely to be seen by any person affected by the determination; and
  - (b) indicate the area of the reserve that is set aside by a determination; and
  - (c) state the activities that are prohibited or restricted in that area; and
  - (d) state any conditions specified in the determination.
- (2) If the Minister revokes or amends a determination made under these regulations, any sign or notice that has been erected or displayed under these regulations must be removed or amended to reflect the revocation or amendment of the determination.

## 10 Directions to leave

- (1) An authorised officer may, in the interests of safety of persons using the Reserve, direct a person
  - (a) to leave the Reserve or an area of the Reserve; or
  - (b) to remain in the Reserve or an area of the Reserve.
- (2) If an authorised officer reasonably believes that a person has contravened any of these Regulations, the authorised officer may direct the person to leave the Reserve or any area of the Reserve.

(3) A person to whom a direction is given under subregulation (1) or (2) must comply with that direction.

Penalty: 20 penalty units

(4) If a direction is given under subregulation (1) or (2), and includes a direction to not re-enter the reserve or any area of the reserve within 24 hours, a person must comply with that direction.

Penalty: 20 penalty units

## PART 3 – RESTRICTIONS ON BRINGING ANIMALS INTO THE RESERVE

## 11 Racehorses

A person must not ride or lead a racehorse in the reserve unless that person does so under and in accordance with a licence issued under section 17B of the Act for that specified purpose.

Penalty: 20 penalty units

## 12 Removal of animal faeces

A person with the care and control of any animal in the reserve must collect and remove from the reserve all of the faeces deposited by that animal.

Penalty: 10 penalty units

## PART 4 – PROTECTION OF NATURAL FEATURES

## 13 Protection of flora

A person must not, in the reserve, fell, pick, take, destroy or damage any flora in the reserve. Penalty: 20 penalty units

## 14 Introducing vegetation

A person must not intentionally or recklessly bring into the reserve any flora, plant or pathogen that may affect plant health.

Penalty: 20 penalty units

## 15 Interfering with rocks or similar natural objects

A person must not, in the reserve, excavate, remove, destroy, damage or interfere with any rock or similar natural feature.

Penalty: 20 penalty units

## 16 Interfering with archaeological or historical remains prohibited

A person must not, in the reserve, excavate, remove, damage, deface, or otherwise interfere with any archaeological or historical remains or relics.

Penalty: 20 penalty units

## 17 Animals and nests

- A person must not, in the reserve, kill, disturb, harass, hunt, capture or take any animal.
   Penalty: 20 penalty units
- (2) A person must not, in the reserve, destroy, disturb or interfere with the nest, bower, display mound, lair or burrow of any animal.

Penalty: 20 penalty units

- (3) A person must not, in the reserve
  - (a) feed, offer food or offer any object as food to any fauna; or
  - (b) permit or allow food to be taken from the possession of the person by any fauna.

Penalty: 10 penalty units

#### Notes

## Penalty Units

These Regulations provide for penalties by reference to penalty units within the meaning of section 110 of the **Sentencing Act 1991**. The amount of the penalty is to be calculated, in accordance with section 7 of the **Monetary Units Act 2004**, by multiplying the number of penalty units applicable by the value of a penalty unit.

The value of a penalty unit for the financial year commencing 1 July 2017 is \$158.57. The amount of the calculated penalty may be rounded to the nearest dollar.

The value of a penalty unit for future financial years is to be fixed by the Treasurer under section 5 of the **Monetary Units Act 2004**. The value of a penalty unit for a financial year must be published in the Government Gazette and a Victorian newspaper before 1 June in the preceding financial year.

### **Other Relevant Legislation**

In addition to these Regulations, the following laws also apply to activities within a reserve -

### **Aboriginal Sites and Relics**

Aboriginal heritage (including Aboriginal objects, places and remains) is protected under the **Aboriginal and Torres Strait Islander Heritage Protection Act 1984** (Commonwealth) and the **Aboriginal Heritage Act 2006** (Victoria). A contravention of this legislation may also result in the imposition of penalties.

#### **Domestic Animals**

The responsible ownership of dogs and cats is regulated by the **Domestic Animals Act 1994** and Regulations made under that Act. Failure to adhere to that legislation may result in the imposition of penalties.

#### Fires

The Forests Act 1958, the Forests (Fire Protection) Regulations 2014 and the Country Fire Authority Act 1958 also limits the lighting of fires in certain areas.

A person who fails to comply with the **Forests Act 1958**, the Forests (Fire Protection) Regulations 2014 or the **Country Fire Authority Act 1958** may be liable to the imposition of penalties.

#### Firearms

The possession, carriage and use of firearms are regulated under the **Firearms Act 1996**. A contravention of that Act may result in the imposition of penalties.

#### Fishing

Fishing is regulated by the **Fisheries Act 1995** and Regulations made under that Act. Failure to adhere to that legislation may result in the imposition of penalties.

#### Litter

The depositing of litter is regulated under the **Environment Protection Act 1970** and may result in the imposition of penalties.

#### Motor vehicles

Under the Land Conservation (Vehicle Control) Regulations 2013, the use or operation of a motor vehicle is not permitted within a reserve except on a road, in a parking area, adjacent to a road, or in an area declared as an off-road access area or a restricted access area where that class of vehicle is permitted. A contravention of those requirements may result in the imposition of penalties.

#### **Historic Places and Objects**

All archaeological sites and relics are protected under the **Heritage Act 1995**. A contravention of that Act may result in the imposition of penalties.

## Wildlife

The taking, hunting or destroying of wildlife, including game, is regulated under the **Wildlife Act 1975** and Regulations made under that Act. A person who fails to comply with the requirements of that legislation may be liable to the imposition of penalties.

## Forests Act 1958

## DETERMINATION OF FIREWOOD COLLECTION AREAS

I, Shaun Lawlor, Acting Assistant Chief Fire Officer, Hume, Department of Environment, Land, Water and Planning, make the following determination under section 57U of the Forests Act 1958.

## Definitions

In this determination and with reference to a numbered item in the table in the determination:

- **Opening** date, being the date on which the determination of a firewood collection area (a) comes into operation, means the date specified in column 5 of the item or, if no date is specified, the date on which this determination is published in the Government Gazette;
- *Closing date*, being the date of revocation of the determination of a firewood collection area, (b) means the date specified in column 6 of the item.

## Determination

Each area of State forest identified in the below table within column one (1) is hatched on a plan lodged in the Central Plan Office of the Department of Environment, Land, Water and Planning, and is a firewood collection area for the purposes of section 57U of the Forests Act 1958, effective from the specified opening date in column five (5) until the identified closing date in column six (6) (inclusive).
