ADMINISTRATIVE ARRANGEMENTS ORDER (NO. 225) 2017

The Governor in Council makes the following Order:

1. Title

This Order is called the Administrative Arrangements Order (No. 225) 2017.

2. Authorising provision

This Order is made under section 3 of the Administrative Arrangements Act 1983.

3. Commencement

This Order takes effect on 8 August 2017.

4. Definitions

In this Order -

'Body' means Minister, Department or officer;

'instrument' includes contract and agreement;

'New Body' means a Body specified in Column 3 of an item of the Schedule;

'Old Body' means a Body specified in Column 1 of an item of the Schedule;

'Schedule' means the Schedule to this Order;

'transaction' includes -

- (a) agreement, bond, contract, deed or other consensual arrangement; and
- (b) action, appeal, arbitration, prosecution or other legal proceeding; and
- (c) assignment, charge, lease, mortgage, transfer or other dealing with property; and
- (d) loan, guarantee, indemnity or other dealing with money; and
- (e) approval, consent, delegation, direction, licence, order, permit, requirement or other authority; and
- (f) notice; and
- (g) any other act, entitlement or liability at law.

5. Construction of references

In respect of each item of the Schedule, a reference to an Old Body –

- (a) in a provision of an Act specified in Column 2 of an item of the Schedule; or
- (b) in a statutory instrument or other instrument made under an Act specified in Column 2 of an item of the Schedule; or
- (c) in respect of any other matter or thing done under a provision of an Act specified in Column 2 of an item of the Schedule; or
- (d) in an instrument specified in Column 2 of an item of the Schedule –

is taken to be a reference to the New Body.

6. Saving of existing transactions

If a transaction happened in relation to an Old Body before this Order takes effect in respect of that Old Body –

- (a) the transaction shall continue in the same way as it would have continued if this Order had not been made; and
- (b) the transaction may be given effect to, or enforced or completed, by or in relation to the New Body in the same way as it would have been given effect to, or enforced or completed, by or in relation to the Old Body if this Order had not been made.
