DECLARATION OF THE MINISTER THAT THE VICTORIAN BUILDING AUTHORITY IS TO CARRY OUT THE FUNCTIONS OF A MUNICIPAL BUILDING SURVEYOR

I, Richard Wynne, Minister for Planning, and being the Minister responsible for the **Building Act 1993** ('Act'), under section 190 of the Act, after having formed the opinion that it is in the public interest to do so, declare that, from the date this declaration is published in the Government Gazette until revoked in whole or in part, all the functions of a municipal building surveyor under the **Building Act 1993** and any regulations made under it in relation to building work on a building or land as specified in the Schedule below are to be carried out by the Victorian Building Authority.

Definition

In this declaration, each of:

- (a) 'the Victorian Building Authority's allocation ID number'; and
- (b) the 'VBA ID';

is the unique number allocated to particular land in the Cladding Ministerial Declaration Register No. 2 of buildings maintained by the Victorian Building Authority.
