National Electricity (Victoria) Act 2005

MINISTERIAL ORDER UNDER SECTION 16BA

I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change and Minister responsible for administering the **National Electricity (Victoria) Act 2005** declare pursuant to section 16BA(1) of that Act that Chapter 7 of the National Electricity Rules has force in Victoria subject to the following modifications.

And I further declare that this Order is for the purpose of matters necessary and consequential on the making of the Advanced Metering Infrastructure (Obligations to Install Meters) Order 2017 made by the Governor in Council under sections 15A and 46D of the **Electricity Industry Act 2000** and published in the Government Gazette on 10 October 2017 (No. S 342).

1. Commencement

- (1) Subject to subclause (2), this Order comes into operation on the day on which this Order is published in the Government Gazette.
- (2) Clauses 2(3) and 2(4) of this Order come into operation on 1 July 2021.

2. Modification of new Chapter 7 – Metering installation components

- (1) In clause 7.8.2(a)(9), after 'type 1, 2, 3, or 4 metering installation', **insert** 'or a relevant metering installation that is a complying remotely read interval meter'.
- (2) In clause 7.8.2(10), after 'a type 4A or type 5 metering installation' **insert** 'but excluding a relevant metering installation that is a complying remotely read interval meter'.
- (3) In clause 7.8.2(a1), **omit** 'installed prior to 1 July 2021'.
- (4) For clauses 7.8.2(a1)(1) and (2), **substitute**:
 - (1) types 1, 2, 3, and 4 metering installations installed prior to 1 July 2021;
 - (2) Type 4 metering installations referred to in clause 7.8.2(b1) installed prior to 1 July 2021; and
 - (3) a relevant metering installation that is a complying remotely read interval meter.'

Note: definitions of **complying remotely read interval meter** and **relevant metering installation** were inserted into Chapter 7 of the National Electricity Rules as in force in Victoria by the 2017 Ministerial Order under section 16BA of the **National Electricity (Victoria) Act 2005**, made on 11 October 2017 and published in the Government Gazette of 12 October 2017 (No. S 346).
