# CROWN LAND (RESERVES) (NATURE CONSERVATION RESERVE) AMENDMENT REGULATIONS 2018

I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change, make the following Regulations.

#### PART 1 – PRELIMINARY

#### 1. Objective

The objectives of these Regulations are to –

- a) amend the Crown Land (Reserves) (Nature Conservation Reserve) Regulations 2004 to include the Frankston Nature Conservation Reserve as a nature conservation reserve; and
- b) revoke the Crown Land (Reserves) (Frankston Nature Conservation Reserve) Regulations 2015.

### 2. Authorising provision

These Regulations are made under section 13 of the Crown Land (Reserves) Act 1978.

#### 3. Commencement

These Regulations come into operation on the day on which they are published in the Government Gazette.

#### 4. Revocation

The Crown Land (Reserves) (Frankston Nature Conservation Reserve) Regulations 2015 published in the Government Gazette No. G31 on 6 August 2015, pages 1710 to 1715, are revoked.

#### 5. Principal Regulations

In these Regulations, the Crown Land (Reserves) (Nature Conservation Reserve) Regulations 2004 which were published in Special Government Gazette No. S241 on 23 November 2004, pages 1 to 29, and subsequently amended by the Crown Land (Reserves) (Nature Conservation Reserve) Amendment Regulations 2014 published in Government Gazette No. G30 on 24 July 2014, page 1614, the Crown Land (Reserves) (Nature Conservation Reserve) Further Amendment Regulations 2014 published in Government Gazette No. G44 on 30 October 2014, pages 2516 to 2521, the Crown Land (Reserves) (Nature Conservation Reserve) Amendment Regulations 2016 published in the Government Gazette No. G9 on 3 March 2016, pages 345 to 346 and the Crown Land (Reserves) (Nature Conservation Reserve) Further Amendment Regulations 2016 published in Special Government Gazette No. S366 on 28 November 2016, page 1, are called the Principal Regulations.

#### 6. Expiry

These Regulations expire on 30 November 2018.

#### 7. Schedule

In the Schedule to the Principal Regulations, after the description of the First and Second Islands Flora Reserve **insert** –

#### 'Frankston Nature Conservation Reserve
