Road Management Act 2004 Interpretation of Legislation Act 1984

MAIN ROAD AND FURLONG ROAD LEVEL CROSSING REMOVAL PROJECT, ST ALBANS

Variation of Designated Road Project


- I, Luke Donnellan, Minister for Roads and Road Safety, having by instrument ('the Determination') dated 1 October 2015 determined that –
- the Main Road and Furlong Road Level Crossing Removal Project ('the Project') is a designated road project under section 16 of the **Road Management Act 2004**; and
- the Roads Corporation ('VicRoads') is the road authority to which the designated road project is assigned; and
- the project area with respect to the Project is the area within the City of Brimbank comprising parts of the road reserves identified by hatching and described in the legends on the plans numbered GP DP_21A, GP DP_21B and GP DP_21C as published in the Victoria Government Gazette S300 on 12 October 2015; and
- the Determination is to operate until 31 March 2018, or if it is earlier revoked, the day on which it is revoked.

now vary the Determination, pursuant to section 41A of the Interpretation of Legislation Act 1984.

- a) by removing from the designated project area from the day on which it is published in the Government Gazette the following:
 - Whole or parts of the road reserves identified by hatching and described in the legends on the plans numbered GP DP_34A, GP DP_34B and GP DP_34C as 'cease to form part of the project area', being the road reserves of Wills Street, Willaton Street, Furlong Road, Bailey Street, Clare Street, Bond Avenue, McKechnie Street, Gratz Street, Gooding Street, East Esplanade and West Esplanade.
- b) by extending 'the Determination' until 31 March 2019, or if the determination earlier revoked, until the day which it is revoked, for the following:
 - Parts of the road reserves identified by cross hatching and described in the legends on the
 plans numbered GP DP_34A, GP DP_34B and GP DP_34C as 'continue to form part of
 the project area', being the road reserves of Willaton Street, Furlong Road, McKechnie
 Street, East Esplanade and West Esplanade.


