### NOTICE OF PREPARATION OF REGULATORY IMPACT STATEMENT

#### Victorian Housing Register

#### Proposed Determinations of Eligibility Criteria, Priority Categories and Priority Criteria for Applicants for Social Housing

A Regulatory Impact Statement (RIS) has been prepared for the proposed Determinations of eligibility criteria, priority categories and criteria for applicants for social housing.

The proposed Determinations, to be made by the Director of Housing under the **Housing Act 1983**, facilitate the allocation of tenancies to applicants on the Victorian Housing Register. The proposed Determinations also revoke the existing Determinations which expire in May 2018.

The proposed Determinations will:

- (a) determine the eligibility criteria that must be met for a tenancy in social housing;
- (b) determine priority categories for social housing; and
- (c) determine criteria that must be met to fall under a particular priority category.

The RIS provides a background to the social housing sector in Victoria and the expected benefits for allocating social housing tenancies in Victoria.

Public comments are invited on the RIS and the proposed Determinations. All comments must be in writing and should be marked 'Director of Housing Determinations Review'.
