Road Safety Act 1986

DECLARATION UNDER SECTION 99B(4) IN RELATION TO NON-ROAD ACTIVITIES IN GOLDEN PLAINS SHIRE ON PERDRISAT ROAD, MAUDE, FOR THE MAZDA GO EOFY FILMING ON SATURDAY 14 APRIL 2018 OR MONDAY 16 APRIL 2018

1 Purpose

The purpose of this Declaration is to exempt participants in the Mazda Go EOFY filming from specified provisions of the **Road Safety Act 1986** and regulations under that Act with respect to the Event, which is a non-road activity to be conducted on the highway(s) listed in Table 2 on Saturday 14 April 2018 or Monday 16 April 2018.

2 Authorising provision

This notice is made under section 99B(4) of the **Road Safety Act 1986**. Section 99B(4) provides that the Minister may, on the application of a person proposing to conduct a non-road activity on a highway, by notice published in the Government Gazette, declare that specified provisions of the **Road Safety Act 1986** and of the regulations made under that Act do not apply with respect to the non-road activity specified in the notice during the period specified in the notice.

3 Commencement

This notice takes effect at 2 pm on Saturday 14 April 2018 or Monday 16 April 2018.

4 Expiry

This notice expires at 4 pm on Saturday 14 April 2018 or Monday 16 April 2018.

5 Definitions

In this notice, unless the context or subject matter otherwise requires –

- Event' means the Mazda Go EOFY Filming, to be held on Saturday 14 April 2018 or Monday 16 April 2018; and
- b) 'Participants' means participants in the Event, including officers, members and authorised agents of Studio Pancho, whose presence is reasonably required to ensure the safe conduct of the Event.

6 Declaration

I, Peter Holcombe Henley, as delegate of the Minister for Roads and Road Safety, under section 99B(4) of the **Road Safety Act 1986**, declare that the provisions of the **Road Safety Act 1986** and regulations specified in Table 1 do not apply to Participants engaged in activities forming part of the Event on the highway specified in column 1 of Table 2 on the date and during the period specified in column 2 of Table 2, provided there is full compliance with any conditions imposed by VicRoads and the municipal council.
