AMENDMENT OF THE PUBLIC LOTTERY LICENCE

Notice is given that on the date below, in accordance with section 5.3.19 of the **Gambling Regulation Act 2003**, I amended the Public Lottery Licence awarded to Tattersall's Sweeps Pty Ltd that commences on 1 July 2018.

Annexure A of the Public Lottery Licence has been amended to remove the Authorised Public Lottery 'The Pools'.

This amendment to the Public Lottery Licence takes effect on the date below.

Tattersall's Sweeps Pty Ltd will still be required to conduct the Authorised Public Lottery 'The Pools' under the Category 1 Public Lottery Licence until that licence expires on 30 June 2018.

AMENDMENT OF THE PUBLIC LOTTERY LICENCE

Notice is given that, in accordance with section 5.3.19 of the **Gambling Regulation Act 2003**, I have amended the Public Lottery Licence (effective 1 July 2018) awarded to Tattersall's Sweeps Pty Ltd.

Schedule 2 of the Public Lottery Licence has been amended to:

- remove the requirement to append the Marketing Plan to the Ancillary Agreement;
- clarify that the requirement to maintain and keep relevant records is for a period of 7 years from their creation;
- change the Lottery System availability requirement from 'at all times' to '99.95% of the time... measured over each and every calendar year of the Term'; and
- change the focus of the monthly reporting on the Lottery System availability requirement from performance for the 'month' to performance for the 'year to date'.

SPECIAL

Schedule 3 of the Public Lottery Licence has been amended to:

- change references to 'Licensee's Head of Retail' to 'Authorised Representative appointed by the Licensee's Head of Retail' in relation to the process of dispute escalation; and
- delete 'Lottery Agents Association of Tasmania (LAAT)' and add 'Lottery Retailers Association (LRA)' as a Distributor's representative body to be notified about a dispute.

Schedule 4 of the Public Lottery Licence has been amended to:

- replace 'Lottery Agents' Association of Victoria (LAAV)' with 'Lottery Retailers Association (LRA)' and replace 'Lottery Agents Association of Tasmania (LAAT)' with 'Australian Lottery and Newsagent's Association (ALNA)' as Representative Bodies to be consulted as part of the commission review process;
- clarify the timeframe for the review process of submissions from Representative Bodies and Individual Distributors; and
- clarify the timeframe for the Licensee's application to the Minister to change the maximum commission rates or the advice to the Minister that no changes are to be made to such rates.
