#### Wildlife Act 1975

#### WILDLIFE (PROHIBITION OF GAME HUNTING) AMENDMENT AND REVOCATION NOTICE

I, Jaala Pulford, Minister for Agriculture, and I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change, make the following Notice:

#### 1. Objectives

The objectives of this Notice are:

- (a) to amend the Wildlife (Prohibition of Game Hunting) Notice published in Government Gazette No. S 112 on 13 March 2018 prohibiting absolutely the taking, destroying or hunting in Victoria of indigenous game birds (waterfowl); and
- (b) to revoke the Wildlife (Prohibition of Game Hunting) Notice published in Government Gazette No. S 152 on 29 March 2018 prohibiting absolutely the taking, destroying or hunting in Victoria of indigenous game birds (waterfowl).

#### 2. Authorising provision

This Notice is made under section 86 of the Wildlife Act 1975 and section 27 of the Interpretation of Legislation Act 1984.

#### 3. Commencement

This Notice takes effect from the beginning of the day which is three days after publication in the Government Gazette.

#### 4. Amendment of Wildlife (Prohibition of Game Hunting) Notice No. S 112

The Wildlife (Prohibition of Game Hunting) Notice published in Government Gazette No. S 112 on 13 March 2018 is amended as follows:

In the table in clause 5, delete 'Private wetland near Stanhope' from the column headed 'Area Name', and delete the corresponding description in the column headed 'Location'.

#### 5. Revocation of Wildlife (Prohibition of Game Hunting) Notice No. S 152

The Wildlife (Prohibition of Game Hunting) Notice (made under section 86 of the **Wildlife Act 1975**) published in Government Gazette No. S 152 on 29 March 2018 is wholly revoked.
