
VARIATION OF THE DESIGNATED PROJECT AREA

Cheltenham Level Crossing Removal Project

I, Richard Wynne, Minister for Planning, pursuant to section 96(3)(a) of the **Major Transport Projects Facilitation Act 2009** (the Act), increase the project area for the Cheltenham Level Crossing Removal Project by designating that land in the vicinity of the project area, and pursuant to 96(3)(b) of the Act designating an area of land as not being part of the project area, as is shown on the plans signed by the Surveyor General with references LEGL./17-422 Sheets 1 of 1 and lodged at the Central Plan Office on 29 March 2018, to be part of the project area for the Cheltenham Level Crossing Removal Project, declared by the Premier to be a declared project pursuant to section 10(1)(b) of the Act and published in the Government Gazette on 21 September 2017.


DESIGNATION OF THE PROJECT AREA FOR A DECLARED PROJECT

Abbotts Road Dandenong South Level Crossing Removal Project

I, Richard Wynne, Minister for Planning, pursuant to section 96(2)(a) of the **Major Transport Projects Facilitation Act 2009** (the Act), designate the area of land shown on the plans signed by the Surveyor General with references LEGL./17-420 Sheets 1 of 8 (inclusive) and lodged at the Central Plan Office on 9 April 2018, and as generally indicated on the map in the Schedule, for Abbotts Road Dandenong South Level Crossing Removal Project, declared by the Premier to be a declared project pursuant to section 10(1)(b) of the Act and published in the Government Gazette on 16 November 2017.
